However, if the solicitor finds that the Will is more complicated, then they are entitled to ask the user to pay the difference between their normal fee for a simple Will and the actual fee. Solicitors are required to notify users in cases where a fee will be charged and agree this, in advance of any Will being written. Solicitors are also free to set a limit on the volume of Wills they have capacity to make as part of the scheme.
