# **Take action for Tep Vanny**


## **Cambodia**

#### **TEP'S STORY**



Tep Vanny lives in Phnom Penh - the capital city of Cambodia. The area of Phnom Penh that Tep Vanny grew up in has the city's largest lake. Surrounding the lake were people's homes, restaurants and businesses.

Ten years ago, the Cambodian government sold the lake and surrounding land to a private company. This has led to thousands of families being forced to leave their homes so that the private company could fill the lake with sand and build a tourist area.

Tep has been standing up for her community's rights by demanding that they are allowed to stay and live in the area.

The Cambodian authorities do not want Tep to take action against them. They have harassed and been violent towards her. However, Tep remains determined to get justice. She has become a symbol of peaceful activism in Cambodia.

Last year Tep was arrested after campaigning for the release of five other people, who have been put in prison for standing up for their human rights.

The lake has been filled in with sand and construction work is underway.

Tep is still in prison and the Cambodian authorities are trying hard to keep her in prison. This sends a message to other human rights defenders and activists that they are not safe to stand up for themselves and others.

- Why do you think the government has leased the lake for construction and development?
- What do you think the government should have done?

We take action for people all over the world, like Tep, who have had their rights taken away from them. We do this through solidarity actions and appeal actions.

What does solidarity action mean? Solidarity actions are sent to the people who have had their human rights taken away, and to their family and friends, to let them know that people are supporting them in their struggle for justice.



# **Take solidarity action – Get creative!**

Make a paper bird or draw a picture of a bird – maybe this could be a spotbilled duck, grey heron, or blue-eared kingfisher, all of which you can find near lakes in Cambodia.

Tell Tep about a body of water you like to visit (e.g. the sea, a lake, a pond), tell her you agree it is important to protect people's homes, and that you hope she is freed from prison soon.

We are sending your messages of solidarity to Tep and hope that this will give her some warmth and strength. We want her to know that we care about her and her cause, to try to encourage her to keep fighting for fairness for herself and the Boeung Kak lake community.



**What does appeal action mean?** Appeal actions are to make people in power sit up and take notice of a cause that you care about. Amnesty is made up of ordinary people across the world standing up for humanity and human rights. Your voice helps to ensure that when we speak, governments listen.

## **Take appeal action**

We are writing appeal letters to the Prime Minister of Cambodia. We want him to tell the government to release Tep Vanny, and grant Tep Vanny an audience to discuss the issues faced by the Boeung Kak community.

Dear Prime Minister Hun Sen,



Tell him about Tep's case.

Urge him to release Tep and allow her to exercise her right to freedom of expression, peaceful assembly and association.

Urge him to speak with her and to speak out publicly in support of Tep and the Boeung Kak community.


