#### Corporate Responsibility & Human Rights

Our monthly action called for greater reporting transparency by business of the risks and impacts of human rights. A letter sent to our MEP called on the EU to strengthen the forthcoming Directive on corporate non-financial reporting on environmental and social issues. Specifically, we are calling for stronger clarity around material impacts; commitment to supporting international human rights standards and EU guidance on how business should report.



## Campaign Action Iran



Our monthly letter is in support of an Iranian human rights defender, **Sayed Ziaoddin Nabavi**. A student and former member of the Advocacy Council for the Right to Education, he is currently serving a 10 year sentence for peacefully expressing his right to protest following the recent elections. He is viewed internationally as a Prisoner of Conscience, and there are fears for his health and for a further unjust sentence after

he wrote an open letter defending a fellow prison inmate. <u>Please address, sign and post the attached letter</u> which will cost 88p to post.

#### Supporting Human Rights in Burma

We are very committed to the people of Burma, and in keeping with a long history of supporting human rights in the country, we wrote to the Burmese Attorney General calling for the release of **Kyaw Hla Aung**, who has been in arbitrary detention since 15 July 2013. This is doubly worrying as his arrest and detention for the peaceful right to protest, comes after the lifting of sanctions and the 'normalisation' of civilian rule. Aung is an ethnic Muslim, part of a stateless minority that have no rights in Burma. Aung is unwell and Amnesty also fears for his health. His case is featured in this year's Write for Rights campaign and we hope you will send a 'Message of Hope' to him.

## Other Campaigns

We signed a Group letter to **MP Jane Ellison** who represents Battersea and Balham. She is the local MP for **Shaker Aamer**, and has campaigned vigorously for his release and return to the UK; now that she is in government, we urged her to continue to pressure government to lobby the US authorities to allow him home. He has now been held without trial in Guantanamo Bay for



11 years and 9 months. He is seriously ill and there are critical concerns for his health and wellbeing. A letter was also circulated to the **Ethiopian authorities**. Human rights have been seriously compromised in Ethiopia, and one of its oldest human rights organisations has almost had to close down owing to punitive legislation that has clamped down on human rights defenders. Members of the **Human Rights Council** have been arrested, attacked and intimidated with only 15% of staff remaining in country.
