

Campaigning: Israel & Tunisia

We signed Group letters to the Israeli and Tunisian authorities. The 550 people living in **Nabi Saleh village** are facing frequent violent repression from the Israeli army. Since 2009, the villagers have held weekly peaceful protests against Israel's military occupation and the illegal Israeli settlement of Halamish, which has taken over most of their farmland. Despite court orders, the settlers have also turned the village water spring into a tourist attraction, which Nabi Saleh residents are prevented from using. The Israeli army also



intimidates the villagers by, for example, declaring the whole village a closed military zone, carrying out night raids, arresting children, and arbitrarily using weapons such as tear gas, which is fired at homes and causes

injury and damage.

Jabeur Mejri was not afraid to express his views on religion. He was jailed in 2012 for seven-and-a-half years after posts he made on social network sites were deemed "insulting to Islam". He is a prisoner of conscience, imprisoned solely for exercising his right to freedom of expression. The Tunisian police arrested Jabeur Mejri on 5 March 2012 following complaints from lawyers who had seen the posts. Within weeks he was put on trial and convicted for

offences that included "attacking sacred values through actions or words" and "undermining public morals".

Monthly Letter: Burma

Our monthly letter is in support of a Burmese community leader, **Dr Tun Aung**. Dr Aung was arrested following disturbances between ethnic Rohyingya Muslims and Buddhists in June 2012. He has been sentenced to 17 years in prison after an unfair trial. Al views Dr Aung as a prisoner of conscience after it was widely reported he tried to calm the crowd and was wrongly accused with inciting the disturbances. New Zimbabwe Minister of Justice Opposes Death Penalty

We wrote welcoming the appointment of **Emmerson Mnangagwa** as Minister of Justice who has said publicly he opposes the death penalty. We also welcomed Zimbabwe's undertaking to ratify the Second Optional Protocol to the International Covenant on Civil and Political Rights. We urged him to work towards achieving this which obliges signatories to take steps towards abolishing the death penalty. We called for a moratorium as a first step towards this aim. Angola, Mozambique, Namibia and South Africa have all abolished the death penalty, whilst Zambia and Malawi have a moratorium in place, thereby setting a positive trend for abolition across Africa.
