**Monthly Letter: Belarus**

Our last campaigning letter of the year relates to Belarus, commonly referred to as the last dictatorship in Europe. **Ales Bialiatski** is a prominent human rights defender in Belarus and the chairman of the organisation Human Rights Centre Viasna. He was arrested on 4 August 2011 and imprisoned on 24 November 2011 for four and a half years. Amnesty International believes that his imprisonment is intended to prevent him working to defend human rights and considers him to be a prisoner of conscience. He did not receive a fair trial. **MP Johnson Writes...**

We received a reply from Orpington MP **Jo Johnson** to our concerns regarding government proposals to hear evidence in secret as part of the **Justice and Security Bill**. Mr Johnson defends the proposals as "judges are currently barred from taking sensitive national security evidence into account in civil compensation cases"; the proposed changes will allow such material to be scrutinised, whilst maintaining national security. Amnesty

fears this is a draconian response that will result in more evidence being heard *in camera* making it harder for defendants to receive justice, and a breach of the fundamental right to hear evidence against you presented in open court.

### Amnesty Extraordinary General Meeting – 12<sup>th</sup> January 2013

If you are an Amnesty member you should by now have received details of an **EGM** to be held on Saturday 12<sup>th</sup> January at Methodist Central Hall. The issues it will address are fundamental to the future of our movement and deserve close attention. The proposers are calling for the restructuring of AIUK to be halted, all redundancies to be stopped and reversed, and for the contribution AIUK makes to the International Secretariat to be frozen until any increase is approved by the membership. Amnesty's strategy and vision to move resources from the 'north' to new hubs in the growing south such as Brazil and India will require savings and cuts to UK resources so that these can be diverted to fulfil the vision. Although potentially commendable, the process has been painful and difficult. The EGM will therefore be an important test for the future direction of Amnesty.
