Article 19 Universal Declaration of Human Rights

Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers

Our whole meeting was devoted to this fundamental human right set out in Article 19 of the UDHR and we were delighted to welcome to the meeting Heather Blake, UK Co-ordinator from **Reporters without Borders**. Heather reminded us that in many



countries reporting the news or revealing the truth can result in a prison sentence or death. 'Reporters without Borders' founded in France in 1985, campaigns tirelessly for press freedom and the right to freedom of expression. It defends journalists and media assistants imprisoned or persecuted for reporting the truth and exposes ill treatment in many countries. Reporters without borders fights censorship and laws that work against press freedom. She reminded us that in 2011, 67 journalists were killed on duty, and so far in 2012, 16 have died on assignment and a further 162 imprisoned. Creeping censorship and clampdown of Internet use has seen 121 people imprisoned for disseminating news reportage on the net. Heather informed us that the early promise of change arising from the Arab revolutions is turning sour, with only Tunisia making headway towards pluralist institutions and freedom of the press. In Egypt, journalists and bloggers face military trial, whilst in Bahrain the media faces harassment and intimidation. In Syria many journalists have been killed as part of a systematic attack on news reporting from centres such as Homs. Freelancers are at particular risk of disappearance and persecution. Finally, as part of her absorbing talk, Heather reminded us that the countries of the Arab spring rank among the worst for 'freedom' with Syria, Bahrain and Yemen receiving their worst ever rankings: 176, 173 and 171 respectively out of 179 countries surveyed. The UK achieves a ranking of 28 – a fall of nine places owing to the phone hacking scandal. Heather reminded us that journalism is a noble pursuit and one relentlessly in the eye of the storm of human rights violations.



Monthly Letter; Iran

Continuing our theme, our monthly letter concerns an Iranian journalist and human rights defender – **Ahmad Zeidabadi** – who is serving a six year prison sentence for writing articles and news reports critical of the Iranian authorities. He has also been sentenced to five years internal exile and banned from taking part in any further political or social activities for life. Ahmad Zeidabadi is a prisoner of conscience for peacefully exercising his right to freedom of expression. There is also evidence that during his imprisonment he was subjected to torture and beatings. Zimbabwe Activists at Risk

We all signed a letter to the Zimbabwe authorities on behalf of six activists who were convicted in March on charges of 'conspiracy to commit public violence'. They were each sentenced to prison and given a fine of \$500 each. Each spent 27 days in prison before the sentences were handed down – all for exercising right to freedom of expression. Originally charged with treason the more severe charge was dropped for lack of evidence. The cases continue a theme of persecution against activists in Zimbabwe.

Syrian Poet Imprisoned



Tal-al-Mallouhi is a student poet, who was sentenced to five years in prison on 14 February 2011. She was charged with 'divulging information to a foreign state' but no evidence of guilt has ever been produced. Charges followed the online publication of her poetry which talks about local and

Palestinian political affairs. At just 20 she is among the youngest student writers to be persecuted by the Syrian authorities as she was just 18 when first arrested outside her school in 2009. This case has been featured by International and English PEN in an attempt to raise the profile of persecuted women writers in particular.
