Doctors on the Dark-side

Stuart explored the history of medical ethics from the Hippocratic Oath in the 5th century BC, to the provisions in the Universal Declaration of Human Rights; the Convention on Torture sets out the right to medical care, health and the right to security, as well as outlawing torture itself. The Declaration of Tokyo (1975) approved by the World Medical Council said torture is contrary to the laws of humanity and in opposition to the higher purpose of the physician. However, in 2002 the US said that waterboarding and other extreme interrogation techniques were 'safe, legal and effective' all overseen by medical practitioners, making them complicit in torture. There have been attempts to correct this: the British doctor, Derek Keilloh, was found guilty of serious misconduct by the UK Medical Council over the death of Iraqi detainees, and struck off. Doctors continue to be complicit in practices directly contravening the Hippocratic Oath, including administering death penalty lethal injections in the US.

Amnesty Prisoner Case File: China

8th October is the exact anniversary of **Dr Liu Xiaobo** being awarded the Nobel Peace Prize in 2010. We sent a second letter to the Chinese authorities, calling for his release. His wife **Liu Xia**, remains under house arrest. Dr Liu is a prisoner of conscience imprisoned for exercising his right to freedom of expression.

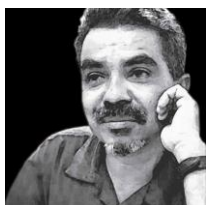

Monthly Action: Sri Lanka



The Sri Lankan government has for years created an image of human rights progress in a country where torture, crushing dissent, and impunity remain an everyday reality. As Sri Lanka gets ready to host the meeting of Commonwealth leaders next month, Amnesty is calling for change. **Prageeth Ekmaligoda** is a journalist and cartoonist who went missing on his way home from work in January 2010. He has not been seen or heard from since. Prageeth was an outspoken critic of the government and Amnesty believes he may have been 'disappeared' because of his satirical criticism of the government. We wrote to the Foreign Secretary, William Hague and the Secretary General of the Commonwealth, calling on them to ensure Sri Lanka protects and upholds all human rights.

Monthly Letter: Iraq

The Group signed a letter to the Iraq Mission in London on behalf of **Mahdi Issa Abu Dheeb**, President of the Bahrain Teachers' Association who has been in prison since April 2011. He was held in solitary confinement and tortured. He has been charged with offences including 'calling for a strike of teachers, inciting hatred, and attempting to overthrow the regime by force'. Amnesty believes he is a prisoner of conscience, imprisoned for expressing his right to freedom of expression.
