#### **Monthly Action: Japan**

**Matsumoto Kenji**, 65, was sentenced to death in 1993 for two separate robberies and murders in the period between September 1990 and September 1991. He appealed against his conviction but this was rejected by the Osaka High Court in February 1996. A subsequent appeal to the Supreme Court was also rejected, and his death sentence was



confirmed on 4<sup>th</sup> April 2000. He could be executed at any time. Matsumoto has an intellectual disability, allegedly due to mercury poisoning which he has had since birth. Mercury poisoning, a common disease in the Kumamoto prefecture of Japan, where Matsumoto Kenji is from, causes damage to the brain and central nervous system. He has a low IQ (between 60 and 70 according to the diagnosis by a psychiatrist) which could have made him more vulnerable during police interrogation. According to his lawyer, police officers coerced him to confess by offering him food. The court, despite his proven incapacity has ruled that he is mentally competent enough to be sentenced to death and that his confession was reliable. Death penalty conditions are especially harsh in Japan, where prisoners are kept in perpetual solitary confinement, forbidden from moving in their cells and taken to execution without prior warning. We wrote to the Japanese authorities calling for the case to be reviewed and the sentence of death commuted.

#### **Monthly Letter: DRC**

There is heightened repression in DRC (Democratic Republic of Congo) against those who speak out against autocratic President, Joseph Kabila. **Fred Bauma** and **Yves Makwambala** are victims of this crackdown for supporting youth activist movement 'FILIMBI' which campaigns to support young people in the responsible and peaceful execution of civic duties. They were detained in March 2015 when security guards stormed a FILIMBI press conference and arrested over



30 people. Fred and Yves were held incommunicado for two weeks and then moved to Makala prison in the capital, Kinshasa. If found guilty of politically motivated activities they could be executed; Amnesty views them both to be Prisoners of Conscience. <u>Please sign, address and send the enclosed letter, which will cost £1.05 to post</u>.

#### **Refugees Welcome!**

Amnesty's global strategic campaign on refugees is to launch this autumn and will be called 'I Welcome'. The aim of this campaign is to promote the view that refugees are welcomed, protected and should be free to enjoy their human rights. The 'Refugees Welcome' march in London took place on September 17<sup>th</sup> with members of the Group attending – this was two days before a



major United Nations meeting in New York addressing the global refugee emergency. We will take part in this important, timely campaign as it rolls out during the autumn.
