Monthly Letter: Mexico

Miriam López, a housewife and mother of four was raped and tortured by soldiers in 2011; she was then arbitrarily arrested in her hometown of Ensenada, Baja California State, in February 2011. They initially held Miriam for a week in a military barracks and interrogated her in relation to alleged drug offences. During that week, she was raped three times and subjected

to electric shocks, stress positions and near-asphyxiation. Her torturers also showed her pictures of her husband and children, and told her that they would "go for them" if she didn't co-operate. Miriam was eventually released without charge in September 2011. So far, nobody has been brought to justice for her treatment. Her story is just one of thousands of similar cases of torture and other ill-treatment in Mexico in recent years. Please address, sign and post the attached letter calling for a full and impartial investigation into the allegations of rape and torture. This will cost 87p to post.

New Amnesty Prisoner Case File: China

We are delighted to have been allocated a new **Prisoner Case File**, the first for several years. We will work on this over the next year or so, sending appeals and raising awareness. We hope that you will take part in these actions. The case concerns **Dr Liu Xiaobo** and his wife Liu Xia. Dr Liu is an academic and political activist, who was taken from his home on 8th December 2006. For six months he was held under 'residential surveillance' and reportedly tortured. He was arrested formally in 2009 on suspicion of 'inciting subversion' and sentenced to 11 years imprisonment, and a further

two years' deprivation of political rights. The trial lasted 2 hours. He has been held in Jinzhou Prison ever since; his wife is an artist and poet and has been held under illegal house arrest since October 2010. Dr Liu has faced intimidation and harassment throughout the 1990s and 2000s and he is viewed as a prisoner of conscience by Amnesty for peacefully exercising his right to Freedom of Expression.

Zimbabwe Elections

We have followed the election process closely in Zimbabwe and its outcome. We discussed serious concerns regarding six women forced to flee their homes. We are investigating taking part in an Amnesty action to ring Zimbabwe police stations where women are known to be held for investigation. The Group signed two letters to the Zimbabwean authorities regarding the latest concerns.
