Pride 2014 – 23rd August

We are delighted to say that Manchester Amnesty will once again be taking part in the Manchester Pride Parade this year. The theme is 'Love is love, no matter who you love', so we will be carrying heart-shaped banners highlighting some of the LGBTI cases that Amnesty is currently working on, as well as our usual 'Love is a Human Right' materials.

The parade route is slightly shorter than usual, due to the ongoing road works in the city centre; it is around 1 mile, and should take approximately 1 hr 45 mins.

We assemble as usual off Liverpool Road, near the Roman Fort. The following schedule will then apply:

- We need to be at the assembly point by 11am.
- At 11.45pm the mayor will judge the parade entries.
- At approximately 12pm the health & safety briefing will take place.
- Parade begins at 1pm.

Campaigning

Stop Torture

At our August meeting, Alice Nicolay, Regional Fundraiser at Freedom From Torture, will speak about the important work that FFT do with torture survivors in the UK. Alice will be joined by two of her colleagues, Hazel Batchelor, Psychological Therapist/Trainer, and Jonathan, Chair of the Experts by Experience group, who will speak about their roles within the organisation.

As well as giving an overview of the work done by FFT, they will touch upon the policy and advocacy work they do and the training and capacity building programmes that FFT run with agencies who work with torture survivors.



Women's Rights

AIUK report that they had a significant role at June's summit of the Preventing Sexual Violence Initiative. Two thousand people (from 123 states) were in attendance London's Excel Centre, including politicians, officials, human rights defenders and members of our Student Action Network Committee, who participated in the youth engagement component of the summit. AIUK hosted 80 Human Right Defenders at our Human Rights Action Centre before the summit, so that they could meet each other and discuss their approach to the event. AIUK, acknowledge that this is a significant initiative that was pushed forward by the previous Foreign Secretary but, as ever, the big question is whether the diplomacy will lead to real improvements

for people on the ground, in some of the most challenging parts of the world.

Myanmar

Amnesty issued a public statement on July 15th calling on the Myanmar authorities to immediately and unconditionally release all those who have been imprisoned simply for the peaceful exercise of their human rights – exactly one year after President Thein Sein pledged to clear Myanmar's jails of prisoners of conscience – a pledge which to date remains unfulfilled.

The full statement is in the separate attachment along with an extract from the Myanmar Times which provides more information.

We have also received 2 Urgent Actions on Myanmar:

1. On 10 July a court in Pakokku District sentenced, 5 journalists to 10 years' imprisonment with hard labour under Myanmar's Official Secrets Act. Amnesty considers all five as prisoners of conscience who must be immediately and unconditionally released.
2. Eight Chin human rights defenders in Myanmar are facing imprisonment for peacefully protesting against impunity for sexual violence in Chin State. If convicted and jailed, Amnesty International would consider them prisoners of conscience

Southern Africa

No news from Zimbabwe this month, however a new country coordinator has joined the Southern Africa team, Josh Hepple, and he is going to cover South Africa and Swaziland. He has already sent us a new Urgent Action on Swaziland (attached with this newsletter).

On 17 July Bhekithemba Makhubu, editor of Swaziland's monthly news magazine The Nation and human rights lawyer Thulani Maseko were convicted on two charges of contempt of court in the High Court in Mbabane, Swaziland. The contempt of court charges arose from two articles published in The Nation magazine in February 2014 in which the convicted men had raised concerns about judicial independence and integrity in Swaziland.

Their allegations of judicial independence seem to have been demonstrated in their own case where the judge presiding over the case had been named in the article which they had written. It has also been said that the judge met with the Minister of Justice shortly before judgement was given. They have been sentenced to two years in prison without the possibility of paying a fine.

Amnesty believe that these two men are prisoners of conscience and therefore are calling for their immediate and unconditional release.

Manchester Literature Festival

For a number of years the Manchester branch of Amnesty International has worked to highlight human rights abuses by asking individuals to read from appropriate literature at the Manchester Literature Festival.



This year we are proud to present an afternoon with Sri-Lankan born artist, writer and film-maker, Roma Tearne. Roma was a Fellow at Oxford Brookes University and has had many national and international exhibitions. It was while working as Leverhulme Artist in Residence at the Ashmolean Museum, Oxford, that she began to write.

Roma's writing is both informed and inspired by her, and her family's experience of fleeing Sri-Lanka. She has written five novels and will be reading from her book Brixton Beach, a TV Bookclub pick and winner of a French Reader's prize, and The Swimmer, which was longlisted for the Orange Fiction Prize. Both novels offer the reader 'a rare insight into the subtle and dramatic ways we are shaped by conflict' and draw on issues of civil war, persecution and torture, migration, self-identity and loss. Roma's talk will be followed by a Q&A and book signing.

News from AIUK

We have received a message from the AIUK chair, Sarah O'Grady with a summary of the July Board meeting decisions, a report of the recent Chair and Directors meeting (where all AI sections are represented) and the Strategy Goals submission form AIUK to the International Board. This latter is particularly interesting and I have attached it with this newsletter, (others available on request from manchestergroup@amnesty.org.uk). Its final paragraph concludes:

'There was a strong feeling coming from our local groups and activists that Amnesty has spread itself too thinly, that we should focus on fewer issues and avoid duplicating the work of other organisations and use our limited resources more effectively. Many cited poverty and human rights as potentially an area that could be de-prioritised. Alternatively, we should seek other ways of supporting that area of work by either working collaboratively with other NGOs or through capacity building. Working on fewer issues would enable Amnesty to respond more rapidly to human rights challenges as they occur and provide sections the flexibility of working on locally relevant issues.'

A Message from the Chester-Wrexham and Colwyn Bay Groups

The Chester-Wrexham and Colwyn Bay Groups are collaborating with Theatr Clwyd in Mold to put on a HR Film Season. It is a really good programme of 7 films over a period of six weeks in October and November, and several of them will be introduced by Group members. They will also have an exhibition in the Theatr for the duration of the Season. Theatr Clwyd is easily accessible from the Wirral, Merseyside and Cheshire and for those planning a few days in North Wales during the autumn a trip to the Theatr may just be thing!

HUMAN RIGHTS: HUMAN DILEMMAS – a collaboration between Clwyd Theatr Cymru and Amnesty International UK. **What would you do if your freedoms were violated – freedom to live in a democracy, to move freely, to be treated equally, to speak your mind? What do you do when the police are corrupt and your family's in danger? Where do you stand on capital punishment?**

THE SQUARE (15) - Thur 9 October

A documentary made during the recent protests in Egypt's Tahrir Square presenting reportage of the events as protests and alliances unravel. Followed by a discussion about regime change led by Bargas Hatem from Conwy Peace Group.

THE MISSING PICTURE (12A) - Wed 15 October

A moving personal account of one man's survival as a teenager during the brutal rule of the Khmer Rouge in Cambodia, told using hand-made clay figures. Introduced by Roger Goldsmith from Amnesty Colwyn Bay Group.

5 BROKEN CAMERAS (15) - Tues 21 October

A documentary made by the residents of a Palestinian border village as it resisted the building of the Israeli Wall on the West Bank. Introduced by Chris Jones from Amnesty Colwyn Bay Group.

HELI (18) - Wed 29 October

A hard-hitting story about a young man in drug-plagued Mexico who feels he's left with no other option than to take the law into his own hands when the corrupt and inept authorities fail him and his family. Introduced by Apolo Santana from Clwyd Latin America Human Rights Group.

PUSSY RIOT: A PUNK PRAYER (18) - Thur 6 November

A documentary about the Russian female punk band who protested their right to be heard in a Moscow church and ended up sentenced to two years in labour camps.

WADJDA (PG) - Wed 12 November

A wonderfully engaging story about a 12-year old girl in Saudi Arabia who wants a bicycle just like her male cousin. The only Saudi film ever to have been made by a woman.

DEAD MAN WALKING (15) - Thur 18 November

An Oscar-winning 1995 true story about the special relationship that springs up between a nun (Susan Sarandon) and a prisoner on death row (Sean Penn). Followed by a discussion about capital punishment led by Alan Sieber from Amnesty Chester & Wrexham Group.
