Guantánamo Bay

Guantánamo Bay was established in January 2002 as a place for the US authorities to hold people perceived to be 'enemy combatants' in this war on terror. The first detainees were transferred to the prison camp on 11 January 2002. Those of us on our group Twitter account

held a day of Guantánamo tweets to mark this shameful anniversary.

Abbas Khan Memorial

Dr Khan was the doctor from the UK who the Syrian authorities claim 'committed suicide' just one day before his release from detention. Several of



us attended a memorial event for Dr Abbas Khan last mont, organised by the local Syrian community.

At that meeting we were asked, 'what will you do?' and we as individuals and members of Manchester Amnesty agreed that we want increase our focus on supporting the people of Syria.

At our February meeting we plan to have a candlelit vigil for Syrian citizen journalist Ali Mahmoud Othman. Ali Othman was part of a network of activists who ran the Homs media centre providing footage and information to satellite



TV channels and news outlets. He was arrested by the Syrian authorities in March 2012 in Aleppo province and has not been seen since the end of May last year. A relative of Ali Mahmoud Othman who lives outside Syria told Amnesty International that in November 2012, the family had received word from an unofficial source that he had been transferred to the infamous Saydnaya Military Prison near Damascus, although Amnesty International has been unable to confirm this...

We held our Annual General Meeting last month. We have a few changes to the group's officers and campaign coordinators – see list opposite. In particular Helen is standing down as chair to concentrate on her PhD and Michelle is also handing over the secretary's job, however they still plan to be involved in the group leading our Middle East and North Africa (MENA) work with a particular interest in Egypt and Syria. Thanks to both of them for all their efforts so far.

Financially we had a good year in 2013 with some good fundraisers. The Acoustic Amnesty event brought in £324, the street collection £325, the Amnestea £216 and the Literature Festival £120.50. This means that we were able to send £1013.37 to AIUK and reserve £261 to invest in group facilities and events in this coming year.

However, we do also rely on donations from group members (£455 in 2013) to help keep the group afloat. It costs us about £600 just to hire the rooms for our monthly meetings. It is that time of year again when subscriptions are due — so please help us out.

Some of you might have picked up some response in the media and on Facebook and Twitter to Amnesty's launch of a consultation on a future policy on sex worker's human rights. At the moment AI has no policy.

Here are some extracts from a recent email received by the group from Kerry Moscogiuri, AIUK Director of Supporter Campaigning and Communications (newsletter editor's emphasis):

'As you will be aware, Amnesty International is conducting a consultation in order to inform the development of a policy on sex workers. While this is a sensitive area, it is entirely appropriate that Amnesty International focuses on this issue. Sex workers are a very vulnerable group of people who face constant abuse of their human rights. That is why Amnesty is currently canvassing opinion and encouraging discussion with our members around the world.
