junta. Sanctioned by him, thou-  
sands of people were subjected to  
torture, unlawful killings, enforced  
disappearances, illegal detentions  
and forcible transfers."*

*"Men, women and children were  
rounded up in their droves by the  
military and taken from their  
homes, most were never seen alive  
by their families again. Amnesty  
International is still supporting  
families and Chilean local organisa-  
tions that are assiduously pursuing  
justice for the victims."*

## **More Reasons for a Bullet-Proof Arms Treaty**

In the Spring of 2012 there was a coup d'etat in Mali by the military, who overthrew the elected government just before planned elections could go ahead. Amnesty International has documented human rights abuses by the Malian military, including extra-judicial killings. It is this government that France, the US and Britain are supporting to fight Islamic militants and Tuareg nationalists in the north of the country.

These rebels and militants in the north are increasingly heavily armed, as a direct result of arms flowing from Libya after the 2011 war and intervention by Western forces. For many years Britain had been arming Gaddafi's government in Libya, switching their support to the rebels/militants in 2011. It is these same weapons that are now being used by Malian military groups opposed to the military rule in Mali, and opposed to French intervention.

A direct result of the French intervention is the hostage crisis in neighbouring Algeria, in which 23 hostages and 32 militants have been killed (at the time of writing). The militants involved are from Mali, and cited the French intervention as the reason for their actions.

All this underscores again the need for an internationally binding set of rules governing the sale of arms, to try and prevent them being used for such human rights abuses. Thankfully, this March, the world's governments are to agree the terms of an international Arms Trade Treaty – the first global treaty regulating the international trade and transfer of weapons.

Oliver Sprague, Amnesty UK's Arms Programme Director, said recently:

"To be effective, this Treaty must have strong and binding rules at its heart that stop anyone supplying or brokering weapons where it is likely that they could facilitate serious human rights violations. In short, it must be bulletproof."

## **Report back from EGM**

On 12th January, several members of the Brighton and Hove Amnesty group attended an Extraordinary General Meeting, held in London. This had been called by members in response to the increase in contributions by Amnesty International UK to the International movement and the restructuring and redundancies that had resulted from this.

There was a great turnout of about 650 people. Due to the proxy votes and block votes for groups (10 per group) the number of votes cast for each resolution was between 2100 and 2400. Mostly the proceedings were good natured, although there were some very emotional and heartfelt arguments on both sides.

For each resolution to be carried it needed a vote in favour of 75% or

more. So although 3 resolutions were not carried, all of them got votes of over two thirds in favour. In fact one resolution only failed by 0.3%. This clearly goes to show the strength of feeling involved and I am sure, must serve as a call to the board to take it's membership seriously.

The attendance of Kate Allen, director of AIUK and Salil Shetty, Secretary General of AI, left no doubt about how seriously the EGM was taken both nationally and on an international level.

Importantly the resolutions that were carried mean that International Secretariat will have to be a lot more accountable about how the money that is sent from the UK section is spent. Also that the UK section will not be able to make any major reorganisation without approval at the AGM.

Gwyneth felt that she came away from the EGM with more questions than answers! " maybe the format of an EGM defined what could be said and what could be discussed,

but I was disappointed (before I even got there) that everything was so focused on a poorly managed redundancy operation, whereas I wanted to know what had gone wrong with the whole implementation of Moving Closer to the Ground: what was behind all these high-level resignations and protests, and why so many people, members, sections and stakeholders were so extremely uneasy."

There will be a discussion on "improving AIUK following the EGM" at the SE Conference on 23<sup>rd</sup> February in Canterbury. This will take the format of a discussion on where AIUK goes after the difficulties surrounding the cut backs and the EGM. A panel of four will give their own views with plenty of time for discussion from the floor.


*Our Greetings card Camping event last December went very well. Thank you everyone who joined, volunteered, helped and brought a smile during the day.*



## Take Action

### INCREASE SUPPORT LEVELS FOR ASYLUM SEEKERS

Those fleeing conflict and persecution should not be left impoverished in the UK.

The great majority of asylum seekers who arrive in the UK are required to live on just over £5 a day. Income Support is set at what is considered to be the minimum amount people need to meet their basic living needs. But many asylum seekers have to survive on the equivalent of just 52% of Income Support while waiting for the Home Office to make a decision on their asylum application. Since most asylum seekers are not allowed work, they have just £5 a day to cover essentials such as food, toiletries clothing and travel (housing and utility bills are paid for separately for those with nowhere to live). While individuals can survive on this amount for a few days, they cannot do so in the long term without any serious consequences to their health.

We are asking MPs to support our call to review the current policy and increase asylum support levels to at least 70% of Income Support – the equivalent of £7 day for a single adult over 25. This would allow asylum seekers to meet their most basic essential living needs while waiting for a decision on their application.

This is how you can help:

#### **Write to your local MP**

Write to your MP to ask them to support this policy and write to their Party Leader or Home Secretary. A sample letter is included in the newsletter. If you have time to write a personal letter this would be more effective.

#### **Organise a meeting with your local MP to discuss this issue**

Many members of the public, including MPs, have negative attitudes towards asylum seekers which are based on misconceptions. It is vital that all MPs consider the policy issues in a balanced way based on factual information. Further information including a Q and A sheet is available on the Amnesty web site <http://www.amnesty.org.uk/content.asp?CategoryID=10046> It is particularly important to engage with MPs from Labour and the other opposition parties as they are beginning to review their policy positions in the lead up to the next general election.

## January Stall

'January brings the snow' but luckily it had melted in Sydney Street for our monthly stall on Sat. 19th. It was still perishingly cold and despite this we decided to hold it for one hour. Peter and Gwyneth bravely volunteered along with Celia and myself as usual.

We had two themes for the stall. Firstly our 'Prisoners of Conscience', the displaced people of Tawargha in Libya. Thirty thousand were pushed out of their town by the military, who were punishing them for allegedly supporting Gadaafi. Their homes were plundered and burnt. These people are now scattered throughout Libya. Some have been detained and some have been tortured. Our petition calls for the interim government to reinstate these people and compensate them for their treatment.

The second subject was Shaker Aamer, who has been at Guantanamo for 11 years now. He was ordered to be released by Obama in 2007 but this has not been done. He continues to remain imprisoned while his wife and children wait for his return in London. He is now the only British resident left in Guantanamo. We collected 60 signatures for his petition from Amnesty. (Please note there is also an on-line petition to make parliament discuss his case. We need 100,000 signatures so check that you have done it !)

## Guantánamo: 11 Years of Tortures

The eleventh anniversary of the Guantánamo Bay detention centre fell on 11 January. Here is a summary-by-numbers of those eleven years:

**779** detainees have been held in Guantánamo, the vast majority without charge or criminal trial.

**166** detainees remain imprisoned as of 19 January 2013.

**9** detainees have died in Guantánamo.

**12** detainees were under 18 years old when taken into custody.

**1** detainee has been given a trial in US federal court.

**7** detainees have been convicted by military commission.

**6** detainees currently face the possibility of death sentences after unfair trial by military commission.

One of the remaining 166 detainees is Shaker Aamer, a British resident. He was cleared for release in 2007 but is yet to be returned to his family in the UK. The US National Defense Authorisation Act has effectively prevented transfers out of Guantánamo Bay for the past two years. In specific cases, however, the US Secretary of Defense can issue a waiver. There is no evident reason for Shaker Aamer remaining in Guantánamo.

Palestinian Prisoners in Israeli Jails: Brutality, Complicit Firms (e.g. G4S) and Palestinian Resistance

SAEED AMIREH is a young experienced Palestinian speaker from the Palestinian West Bank village of Ni'lin, which is in the frontline of non-violent resistance to the Israeli Occupation. Using previously unshown video material from inside prison that he managed to take himself, he will speak from his own and his family's experience of Israeli arrest, detainment and jail conditions, including torture - realities which almost all Palestinian families have to face. He will also speak about Palestinian prisoners resistance, through non-compliance and hunger strikes, and about the role of complicit firms such as G4S in the operation of the prisons in Israel where Palestinians from the West Bank are held.
