Round up of June group news

Hot news this month is the publication of Amnesty's latest report on Internally Displaced People (IDP) in Afghanistan, 'My Children Will Die This Winter: Afghanistan's broken Promise to the Displaced'. The shocking statistic is that the number of people displaced by violence has more than doubled in the last three years, from around

500,000 to **1.2 million**; in addition, an estimated 2.6 million Afghan citizens are living outside the country as refugees. IDPs in Afghanistan are mostly living in desperate conditions in very basic camps, with inadequate food, water, shelter and healthcare, and very limited opportunities for education or employment. Despite passing a new IDP policy in 2014, spelling out the rights of IDPs and a plan for implementation, the Afghan government is providing little or no support to these people and in fact subjects them to harassment and forced eviction. Only a small number of international NGOs are active in the country and they are under-funded. The world's attention has moved on since withdrawal of international troops at the end of 2014, with UN humanitarian funding much reduced. The report calls on the Afghan government and international community to ensure the most urgent needs of IDPs are met and the new IDP policy is implemented immediately.

- '... Our situation has gone from bad to worse. I feel like we are forgotten, there is no attention on displaced people anymore.' Quote from a 16 year old IDP girl in a camp in Kabul.
- '...I would prefer to be in prison than this place at least I would not have to worry about food and shelter.' Quote from a woman in a camp in Herat.

Campaign News

Women's Action Network

Encouraging news from Saudi Arabia as the Justice Minister has ruled that all clerics must provide a copy of the marriage certificate to the bride as well as the groom, to ensure women are aware of the terms of their marriage contract and their rights. Since marriage contracts are negotiated by male family members, this is highly significant in safeguarding women's rights.

The battle to decriminalise abortion continues in Northern Ireland, El Salvador and Argentina. In Argentina, a 27-year old woman called Belen has been in prison since she had a spontaneous miscarriage in March 2014. Police officers surrounded her hospital bed after hospital staff reported her. She was subjected to a degrading examination, arrested, held in pre-trial detention for two years and charged with murder, for which she was sentenced to 8 years in prison. Her appeal in May 2016 was denied and she remains in detention. **Please sign and send the letter calling upon the Argentinian authorities to release Belen.** (Letter previously circulated by email.)

Ethiopia

British citizen Andy Tsege continues to be held in prison in Ethiopia, although there has been some improvement in his conditions and he now has access to regular consular visits, local family visits and medical care. According to a reply to our letters, the UK government, through the Foreign Office, continues to raise his case with Ethiopian officials. His nine-year old daughter has said she will sue the UK government over its handling of his case.
