

Refugee Week Opening Concert

This year 'Brighton and Hove Sanctuary on Sea' are organising Refugee Week. (18th - 29th June 2016)

Some of the events include a public debate on the Refugee crisis, a satirical one - woman show at the Marlborough Theatre and Refugee Table Tennis.

I attended the opening concert, part of the 'Crossing Borders Festival' of jazz and classical music. Pete Davison conducted the Regent's Orchestra in St Mary's Church, Kemptown. Kate Allen (Director of Amnesty UK) gave a short speech at the beginning challenging our preconceptions of the Refugee crisis. She pointed out that a million refugees coming to the UK was not a crisis compared with 4 million refugees in a small country like the Lebanon.

There was music by Benjamin Britten who was a conscientious objector and became a refugee in USA. Shostakovich was evacuated from Leningrad during WW2 in an attempt to evade being forced to join the Communist Party. Samuel Barber wrote 'Adagio for Strings' which was used in the soundtrack for the film 'The Deer Hunter'.

The music is poignant and evocative, very suited to contemplation of the refugees' plight. The whole concert was born out of the desire to celebrate the achievements of the many musicians who encounter some form of exile and also to make refugees welcome.

Campaign HOSSEIN RAJABIAN, MEHDI RAJABIAN AND YOUSEF EMADI

These three men have been sentenced to 6 years in prison. They have been found guilty for their artistic work, including a film by Hossein dealing with women's rights to divorce in Iran and Mehdi and Yousef's distribution of unlicensed music by Iranian singers from outside the country covering taboo subjects.

They allege they were tortured and held in solitary confinement and have not had access to a lawyer.

We managed to get 90 letters signed from the passers by on the street. We will be sending these to the Ayatollah in Iran calling for him to overturn the Court's ruling on the three men.

SYRIA ACTION – HELP ENSURE HUMAN RIGHTS BENCHMARKS ARE EFFECTIVELY ADDRESSED IN THE SYRIA PEACE PROCESS

5 YEARS since the start of the crisis, Syria has become the epicentre of the world's worst human rights and humanitarian catastrophe. Violence and insecurity, targeted with indiscriminate attacks against civilians, mass arrests and widespread torture in detention facilities, deliberate denial of assistance and the collapse of services have prompted over 4.5 million people to flee the country and 7 million more to abandon their homes inside Syria.

UN Security Council members are not doing enough to end the crisis and some of them are actively fuelling it. A number of resolutions to provide humanitarian relief and protect civilians have been passed and ignored. 5 years on Syria must take priority over political interests. Is our government doing enough?

Contact your MP and ask them to write to the Foreign Secretary Philip Hammond, to ensure the UK champions human rights at the Syria talks and lobbies parties to the conflict to :

END UNLAWFUL ATTACKS AGAINST CIVILIANS AND CIVILIAN OBJECTS

LIFT THE SIEGES

ALLOW UNFETTERED HUMANITARIAN ACCESS

RELEASE THOSE DETAINED AND ABDUCTED SOLELY FOR EXERCISING THEIR HUMAN RIGHTS

ENSURE EFFECTIVE PARTICIPATION OF WOMEN AND CIVIL SOCIETY IN PEACE TALKS

END IMPUNITY – ALLOW INDEPENDENT MONITORS ACCESS TO THE COUNTRY

"A Shameful Relationship:
UK Complicity in Saudi State Violence"

David Wearing is a writer, academic and author of a new report on UK arms sales to Saudi Arabia. He will be in Brighton to discuss his findings on Tuesday 5 July.

British arms are being used by a Saudi-led coalition to indiscriminately kill civilians in Yemen and to enforce authoritarian rule in Saudi Arabia. Since David Cameron entered Downing Street, £24bn of arms sales have been approved for export to the Saudis. This trade is dangerous and destructive and must be stopped.

Campaign Against Arms Trade (CAAT) are now calling for a judicial review of the government's decision to keep arming Saudi Arabia, arguing that the sales are unlawful and in breach of arms export regulations.
