# **Campaigning**

# **Refugee Campaign**



On 19 September there is a special UN assembly to discuss the refugee crisis. The meeting will be a chance to achieve worldwide agreement to resolve the refugee crisis and improve the lives of refugees. Making sure the UK takes its fair share of responsibility is critical to reaching any lasting agreement to helping refugees. In order for the UK to do more we need to show the Prime Minster that people from across the UK want more to be done to help those fleeing war and persecution.

To demonstrate this, there will be a march in London on 17 September and in every other capital within the UK. The march is being organised by Solidarity Refugees and Amnesty is one of the many organisations lending support.

How can we help? A major feature of this campaign is the refugee pledge. We are asked to get people from across Manchester to sign the pledge and promote the action in regional media and online we hope to demonstrate there is support for refugees across the UK. The pledge calls on the Prime Minster to lead in delivering a humane and affective response to the global refugee crisis.

We made a start of this at the Acoustic Amnesty event – when we also raised money for the City of Sanctuary in Manchester.

### Middle East

As Manchester has close links with the United Arab Emirates (via Manchester City Football club and the UAE's stake in the Manchester life Development Company for example) we are concentrating our efforts on this area. In particular, we have



started campaigning on behalf the human rights Lawyer, Mohammed al-Roken who was jailed for 10 years in July 2013.

We spent some time at our last meeting discussing the UAE. Henrike and Hayley explained the issues and showed a couple of videos. If you weren't there, have a look at:

In July, in conjunction with researchers from the Amnesty International Secretariat and Human Rights Watch, we had

meetings with both the Bishop of Manchester and Sir Richard Leese, the leader of Manchester City Council, to discuss our concerns and to ask them to raise these with any contacts that they have. We feel that Manchester leaders raising the issues publically will be of concern to those in power in the UAE and could help make an improvement in the country.

#### **ACTION ON THIS CASE:**

The UAE group held a meeting this month to plan their participation in the Peterloo Tapestry event on the 14<sup>th</sup> of August. The Peterloo Memorial Campaign Group's commemorative event will be the creation of a public participative artwork in the form of an evocative tapestry and the idea is to address the case of Mohammed Al-Roken on that day on the tapestry. ## **North Africa**

# **EGYPT** –Cambridge student found murdered

In 2011, the body of Giulio Regeni, an Italian PhD student searching into Trade Union rights, was found dumped in the outskirts of Cairo with torture marks redolent of the practices of the Security services. Since then the Italian and British governments have asked the Egyptian authorities to investigate into the murder. The case has been dismissed as an attack by thugs.

Giulio's fate is shared by thousands of Egyptians and foreigners, who 'disappear'. Al highlights that information about conditions in Egypt come from brave researchers like Giulio and his case will be featured in the Write for Rights campaign from Nov/Dec 2016.

Both the Italian and British governments have valuable arms and trade deals with Egypt, which allegedly has made them less willing to put pressure onto the Egyptian authorities to cast light onto this case.

For unknown reasons the University of Cambridge has not answered to calls for co-operation into providing information that could be useful to resolve this case.



## **MOROCCO -WAFAE CHARAF released**

Wafae Charaf was jailed for two years for reporting torture. She has now been released!

In May 2016 Laura distributed solidarity cards in support of Wafae at the stand we had at the teather in Salford Quay, in occasion of the play 'The Last Resort'.

#### LIBYA -We need a plan B

According to the International Organisation for Migration about 264,000 migrants and refugees are currently in Lybia. Most of them are escaping horrific conditions in their original countries.

In May 2016 the EU has extended Operation Sophia for another year. This is an anti-people smuggling mission in the Mediterranean with the aim to build up capacity of the Lybian coastquard and immigration authorities.

However, evidence gathered by AI reveals serious abuses by the Lybian coastguard and immigration detention centres in Libya. The evidence includes allegations of abduction, torture, sexual violence and leaving people on sinking boats to drown.

Al is putting pressure onto the UN-backed Government of National Accord (the current form of Lybia's government) to restore the rule of law and also onto the EU to re-think their strategy to let the Lybian coastguard manage the flow of refugees and migrants across the Mediterranean.

Al wants the UK government to review its approach to refugees (see the Solidarity with Refugees march and rally in London).

#### **TUNISIA -LGBTI rights**

Tunisia's authorities are still unwilling to change laws that criminalise same-sex consensual sexual relations, leaving LGBTI people live in constant fear of being discriminated, harassed, attacked and arrested.

At the meeting we will do an action in support of the LGBTI Community in Tunisia.

### **Southern Africa**



#### ANGOLA -JOSE' M. MAVUNGO released

The Angolan Supreme Tribunal acquitted human rights defender José Marcos Mavungo on 19 May and he was released the following day. He is now home with his family.

Jose' Marco Mavungo is part of the 17 Angolan activists for which we sent letters iin May 2016.

- Francisco Mapanda, an **Angolan** youth activist charged with contempt to Court;
- Benedito Sabao, a citizen of **Mozambique** who as no means on living and is prevented from leaving the country by the coutry's authorities:
- -Evan Mawarire, a pastor and leader of the social movement #This Flag in **Zimbabwe** (http://www.bbc.co.uk/news/world-africa-36794384) whose life is at risk;

#### **Individuals at Risk**

We held our regular letter writing session on 23rd July. We wrote 46 letters and solidarity messages on behalf of a number of victims of human rights abuses, including Mohammed al-Roken in UAE, the Roma community in Italy, Costas, a Greek man who suffered a homophobic and racist assault along with his partner, who is a refugee, and Chelsea Manning, who has recently attempted suicide while serving a 30-year prison sentence for blowing the whistle on potential human rights by the American military. Sadly we have heard since the letter writing session that Chelsea may face further punishment in prison, including indefinite solitary confinement, for attempting suicide. This is outrageous and shows how we need to keep up the pressure for Chelsea and all other victims of human rights abuses.

Planning has started for this year's Write for Rights campaign which will start in November in the run up to Christmas. We are hoping to work with the Challenge Project and Whalley Range Peace and Justice Group again but will probably do a stall or two ourselves.
