


### **Next Letter Writing Session**

# Campaigning

## The Human Rights Act challenge

AIUK are challenging us to come up with the most creative way to visually represent the Human Rights Act. The subgroup have come up with a plan for a pop up street theatre action - to take place on Saturday 16th January in Manchester City Centre provided that we have enough volunteers to take part.

### Southern Africa

At our January meeting Simona will bring along an urgent action (letter to sign) for soldiers in Lesotho, a country with significant political instability. After the dismissal of the Head of the Lesotho Defence Force, 50 soldiers have been arrested and allegedly tortured. 23 soldiers are still being detained and are facing a trial on 1st February 2016. There is concern that the trial will not be fair. If found guilty they face death penalty. She will also have updates for South Africa and Swaziland on campaigns that AI has followed through the years.

### Burma (Myanmar)

We have been allocated the Unity 5, 5 journalists imprisoned in 2014 for doing their jobs, as our special case to work on long term and we hope to receive appeal postcards in Jan. More details on this case can be found at
