A Busy December!

The group had a hectic end to 2014 with a letter writing session on Saturday 22nd November at The Eighth Day Café concentrating on the cases featured in this year's Greeting Card Campaign - a video clip was recorded and sent to AI Poland who have put together this lovely compilation of Greetings Card campaigning around the world.

On 6th December we had stalls at Birch Community Winter Fair to promote the Greeting Card Campaign and at the Write for Rights event organised by Whalley Range Peace and Justice Group selling Christmas cards and promoting the Tools of Torture petition, calling on the EU to close the loopholes that allow people to profit from the trade in torture equipment for which collected 75 signatures at this and Acoustic Amnesty.

Following this there was Acoustic Amnesty at Sacred Trinity in Salford on Human Rights Day, featuring the Manchester Samba band, The Greater Manchester Humanist Choir, Stone Flowers and three performance poets - Kieran King, Rod Tame and Martin Stannage. More cards were signed, and £413 raised for Amnesty and Musicians without Borders. Huge thanks to Steve and all performers.

And lastly, the following Saturday, we had a Greeting Card Campaign stall outside the Unicorn in Chorlton. The Amnesty stalls generated 215 signed cards and 40 appeal letters. The Whalley Range event generated 513 cards and (combined with their earlier folk event) a donation of £1500 for Amnesty.

Children's rights

Following on from our recent actions on children's rights, we're delighted to welcome David Maidment, leading member of AIUK's Children's Network and founder of Railway Children, to our January meeting.



For decades, David has been key in keeping children's rights on the AIUK agenda. The Network now operates as a blog, with cases and campaign actions for individuals to act on at www.amnesty.org.uk/blogs/childrens-human-rights-network

David's job in safety policy at British Rail took him to India where the dire situation of children living in and around railway stations affected him strongly, and he came away determined to bring about change. The result was Railway Children which now works with children living on the street in India, East Africa and the UK. The charity's workers seek out vulnerable children, offer them safety and security, and reunite them with their families when this is possible.

Workshop

Country Coordinators are holding a conference entitled **'How Activists Can Campaign for Safeguards'** on 14 February at the HRAC in London. This conference will discuss:

- Why safeguards matter and how much difference they can make
- When/where they should be effectively introduced
- How to campaign for safeguards

Speakers will include Craig Murray, the former UK ambassador to Uzbekistan and outspoken critic of torture. In 2002 in a speech to his fellow diplomats and Uzbekistani officials he highlighted the 'prevalence of torture in Uzbekistani prisons.' He was removed from his post in October 2004. He's also the author of *Murder in Samarkand*, a memoir of his experiences. Those who have heard him before know what an entertaining speaker he is.

Women's Rights

EU strategy

The following is taken from the December letter from the AIUK chair:

The landmark human rights moment for the month has been the agreement by the European Union of a Human Rights Defenders strategy for Afghanistan.

Conscious of NATO's departure at the end of this year and an increasing sense of insecurity, AIUK activists have been working for the past two years to highlight the need to support women in Afghanistan, in particular women human rights defenders, a term that applies to anyone helping to deliver human rights for others – teachers and doctors, as well as journalists or more politically-minded activists. Eventually, your pressure, our staff's work and the inspirational work of Afghan women themselves led to a strategy that is amongst the very best that our experts have seen. I am very proud that we achieved this together and I believe it will have real impact on women and men who place themselves at risk to help realise human rights for others.

Chorlton Arts Festival

We are continuing with plans to stage "Even if we lose our lives", a compilation of interviews with Afghani women, at the Chorlton Arts Festival, in May this year. With the help of the Ice and Fire theatre company, we are seeking three local female actors and a director.

AIUK News

General Election

Anne Walker, our local volunteer trainer, is attending a training session in London in early January to prepare to help groups with work in the run up to the General Election. She will deliver a workshop based on this training to the group at our March meeting.

In January 2014, a new piece of legislation received Royal Assent. Officially it's known as the Transparency of Lobbying, non-Party Campaigning and Trade Union Administration Act 2014 – but more usually referred to as the Lobbying Act. AIUK has issued guidance to groups on how this might affect us, see:

Basically this legislation should not stop us doing any campaigning but anything that could be construed as lobbying e.g. on the Human Rights Act which the Conservative Party wish to repeal, will come under the Act and we will need to keep details of any expenditure and provide them to AIUK. It is unlikely that this will be significant but Sean, our treasurer, will coordinate any returns that we need to make.

Strategic Goals consultation

At the International Council Meeting in August a new set of Strategic Goals for the international movement will be agreed. We discussed a draft at our October meeting last year and passed on our views to AIUK.

Following this consultation, AIUK submitted its response in October, which is attached. Whilst AIUK applauds the progress being made, they believe that some changes are necessary, including the need to give more visibility to Amnesty's "signature" issues (such as our work on prisoners of conscience, the right to a fair trial and the death penalty) and to simplify and clarify some of the language that has been used to date. This all seems very much in line with our discussions.

A further draft is expected in the New Year and our views will be asked again.
