Individuals at Risk

Chelsea Manning

In his final week in office, Barack Obama has pardoned Chelsea Manning. Instead of serving a 35-year sentence, she will walk free in May. Chelsea was sentenced after blowing the whistle on potential crimes under



international law and human rights violations by the U. S. military. Amnesty International considers her a prisoner of conscience and the Manchester Amnesty group took part in writing letters calling for her release last year. She was held in pre-trial detention in conditions that the UN Special Rappoteur on Torture deemed to be cruel, inhuman and degrading treatment. She is transgender but was denied appropriate medical treatment

relating to her identity. She attempted suicide while in prison and was placed in solitary confinement in response. It is fantastic news that Obama has listened to calls to set her free - a huge thank you to everyone who campaigned for her.



Write for Rights

We took an active part in the 2016/17 Write for Rights campaign with 3 sessions (Unicorn in Chorlton, Birchfields Community Centre and St Andrew's, Dearnley) involving members of the public writing solidarity cards. In addition, our November letter writing session was dedicated to writing appeal letters on behalf of the Write for Rights cases and our December group meeting to sending solidarity cards.

Overall some 160 solidarity cards and 35 appeal letters were sent.

Many thanks to all who took part and especially to Hazel, Rosemary, Jo and Mary who organised our efforts.

United Arab Emirates

What has happened in 2016?

In May the group adopted the case of Dr. Mohammed Al-Roken, a human rights lawyer who is imprisoned because he called for democratic reforms.



Help

needed

We participated on his behalf in several events, such as three Acoustic Amnesty events, the Manchester half-marathon, and several Amnesty Write for Rights event. We also organised a "party" on his birthday in the Manchester city centre, where we shared cakes and informed Manchester citizens about Mohammed's situation.

Overall we send 310 signatures to Sheikh Mohammed bin Zayed Al Nahayan, 37 to Sheikh Khalifa bin Zayed Al Nahayan, 38 to Sheikh Mohammed bin Rashid Al Maktoum to call for his release. We also collected 24 signatures on behalf of Mohammed al-Roken that were sent to MP Rebecca Long-Bailey. She has been in contact with our Amnesty group and supported our work fantastically, in particular by raising several questions to the Foreign and Commonwealth Office. The group also collected 297 signatures on the letter to Sir Richard Leese, with whom the group also held a meeting last year to discuss the situation of Dr. Al-Roken and how Manchester could influence it.

So in total 706 signatures have been sent on behalf of Dr. Al-Roken, as well as an open letter signed by 3 councillors, 3 MPs and several solicitors has been sent to the Deputy Prime Minister of the UAE Sheikh Mansour bin Zayed Al Nahayan and we should not forget that more than 50 people added their photo to our photo-collage.

Refugee Campaign

We have received the attached urgent action about refugees and migrants freezing in Serbia. Please email and write to the Serbian authorities. Sample letters are attached

- An estimated 1,200 refugees and migrants are sleeping rough in abandoned warehouses in central Belgrade.
- They are being exposed to disease and inhuman living conditions and, with winter temperatures reaching -20 degrees Celsius, they are at serious risk of illness and even death from frostbite and hypothermia.
- The Serbian authorities are failing to provide them with adequate food, water and sanitation, healthcare, appropriate clothing and basic accommodation.
- No attempt has been made by the Serbian authorities to identify particularly vulnerable people, including children and people requiring immediate medical treatment.
- Unaccompanied children as young as 11 represent a quarter of the population in the warehouses, according to UNHCR.
 They are at risk of further abuses and are particularly vulnerable to the harsh living conditions and exploitation.
- In November 2016, the government informed NGOs providing assistance that their support outside formal centres was "no longer acceptable", while signalling that their capacity would not be increased.

Burma



As you might have seen on the news, Amnesty International has published a new report warning the treatment of the Rohingya in Northern Rakhine State may amount to crimes against humanity.

The report is attached with this newsletter. It is called 'We Are at Breaking Point' and outlines evidence documented from 35 interviews with Rohingya from Northern Rakhine State, as well as satellite imaging of villages burnt down by the Burmese army and Border Guard Police. This evidence confirms reports of unlawful killings, arbitrary arrests, possible enforced disappearances, rape and sexual violence, destruction of homes, property and documents. Furthermore Amnesty International is very concerned that the continued denial of humanitarian access, including food and medical care, is putting lives of the over 150.000 people reliant on aid at risk. The way Rohingya are indiscriminately targeted is a collective punishment, which may amount to crimes against humanity.

The report and campaigns target both the Burmese and Bangladeshi authorities. There are serious concerns Bangladesh

is pushing back Rohingya refugees into Myanmar, contrary to the international principle of non-refoulement. The Rohingya that do reach Bangladesh have to stay in hiding, not having adequate access to food, clothing, shelter and medical care.

Northern Africa

The tide of dissent and the quest for justice continues in Northern Africa. So do the Governments' attempts to stop this. Currently there are many activists convicted for expressing their opinion and for asking for a fairer society. Here is an update:

Algeria

Hassan Bouras is a journalist, a human rights defender and a leading member of the Algerian League for the Defense of Human Rights (LADDH) in El Bayadh, Western Algeria. In 2016 he produced video interviews of local residents stating that high-ranking judicial and security officials in El Bayadh took bribes and imprisoned innocent people on trumped up charges. The video was broadcast on a private satellite television channel with substantial audience in the country. On 28th November 16 Hassan was convicted for complicity in offending a judicial officer, law enforcement officers and a public body. The interviewees were also arrested. Letters will be sent to Algerian Authorities on Hassan's behalf.

Egypt

Mahmoud Abu Zeid [Shawkan] has featured in a number of newsletters. His trial has now been adjourned until the 17th January 2017. As a group we have written a number of letters to officials [including the president] asking for his release. The fact that he has been charged with murder makes the case very urgent. He could face the death penalty if convicted.

Libya

Jabir Zain is an activist, who advocates for women's rights and posts opinion on Facebook on issues that are deemed controversial in Libyan society. On 25th September 2016 as he was leaving a seminar on women's rights held by an NGO, he was abducted by Tripoli-based militia, which operates under the Ministry of Interior. Jabir has been accused of atheism, moral indecency and collaborating with foreign NGOs. His family has received information that Jabir was beaten and tortured by the militia. His whereabouts and well-being are unknown. We will send letters to Libyan's authorities on Jabir's behalf.

Tunisia

On 24th November 2016 Walid Zarrouk, a NGO founder, was sentenced to 26 months in prison in two separate cases. The first case relates to Facebook posts, through which Walid criticised the judiciary and the security forces' handling of investigations on the Bardo Museum attack in 2015 and the killing of politician Chokri Belaid in 2013. The second case relates to criticism

posted through Facebook of a former Minister of Justice and the Public Prosecutor. Walid is protesting against his conviction through a hunger strike and he is refusing to drink water and take medicine for a heart condition. His health is deteriorating and there are also fears for his safety. Walid is a former prison officer, outspoken on terrorism-related issues, and is currently sharing a cell with 13 individuals accused of terrorism offences. We will send letters to Tunisian authorities on behalf of Walid.
