## Campaigning

### Middle East

We are taking on working for human rights lawyer Mohammad al-Roken as a long term case. In June 2013 he was among 69 Emiratis jailed in a mass trial tainted by credible allegations that the defendants were tortured in pre-trial incommunicado detention. From the court documents, it is clear that they were convicted solely for peacefully exercising their legitimate rights to free expression and association. UAE authorities provided no credible evidence to substantiate their claims that the men were plotting to overthrow the government.

A few of us attended a meeting, along with a staff member from AIUK and a researcher from the IS, with one of the City councillors to discuss our request that the council use its influence with the UAE to raise human rights concerns. We hope to take this forward with a meeting with the leader of the City Council, Sir Richard Leese, next month.

### North Africa

#### **ALGERIA: Repression on the rise in Algeria - peaceful protesters face imprisonment**

Protests against poverty, unemployment and corruption are frequent in this oil-rich country. The falling oil prices are causing a rising of unemployment and a worsening of the economy, leading to an increase of protests.

The Algerian authorities rely on repressive laws to quell peaceful dissent. Prior authorization is required to hold public gatherings while an outright ban on public protests is in place in the capital Algiers.

Four protesters from Ouargla, South Algeria, are facing up to a year in prison for taking part in protests against unemployment in Algeria's oil capital, Hassi Messaoud.

These men are all part of the National Committee for the Defence of the Rights of the Unemployed (CNDDC), and have been charged with taking part in "unarmed gatherings" in 2015.

Their trial has started on 19th May 16 and if convicted, Amnesty International would consider them prisoners of conscience jailed solely for exercising their right to peaceful expression and assembly. Action might follow.

#### **EGYPT: Photojournalist, Mahmoud Abu Zeid (Shawkan) risks death penalty**

Cairo, 26 March 2016: a public prosecutor directed nine phony charges against Shawkan. Before the trial, Shawkan's lawyers were denied access to key documents related to the case, including the charges sheet.

Shawkan was arrested while doing his job. He was photographing security forces' violent behaviour in Cairo's street protests. He has been in detention for more than two years, in violation of Egyptian law. His health is deteriorating and he has been denied access to medication, despite suffering from Hepatitis C.

Amnesty International considers Shawkan as a prisoner of conscience, arrested while peacefully practicing his work.

At the meeting we will sign a letter for the Public Prosecutor in Cairo.

### Southern Africa

#### **ANGOLA: Release of Jose' Marcos Mavungo**

20th May 2016 -Good news !

Jose' Marcos Mavungo has been released from prison. He was arrested in March 2015 for organising a peaceful demonstration. In November 2015, as a group, we sent a letter on this case.



#### **MALAWI: Lives of people with Albinism at risk**

Thousands of people with albinism live in fear of being abducted or killed by criminal gangs in Malawi, where their body parts are sold for use in rituals.

Since December 2014 at least 14 people with albinism are known to have been killed in Malawi, while five others have been abducted. Their fate and whereabouts remain unknown.

"We call on Malawian authorities to ensure that suspected perpetrators of these horrific crimes are brought to justice, and to address the root causes of these killings, which have left people with albinism living in constant fear," said Muleya Mwananyanda, Amnesty International's Deputy Director for Southern Africa.

#### **ZIMBABWE: Pro-democracy activist Itai Dzamara still missing –his brother attacked by State Security agents**

On 18th April 16, during Independence Day's celebrations at Harare's National Sports Stadium, Patson Dzamara staged a peaceful demonstration, simply holding up a placard reading "Independent but not free – where is my brother Itai?"

Patson is the brother of the abducted pro-democracy activist Itai Dzamara, who disappeared in March 2015 after he was bundled into a car by five unidentified men in Harare. He has not been

seen since. Despite repeated requests, the Zimbabwean government has failed to provide answers to the Dzamara family.

For his peaceful demonstration Patson was punched, beaten and forced to drink about 4 litres of water by State Security agents.

This "is yet further evidence that the Zimbabwean government is prepared to lash out at anyone highlighting its appalling human rights record," said Deprose Muchena, Amnesty International's Director for Southern Africa.

## Individuals at Risk

Eleven people attended the last letter-writing session at Eighth Day café in May. Between us we wrote 40 letters on behalf of individuals who had been tortured or were at risk of torture. We also sent 15 cards on behalf of two human rights activists in Morocco. This letter-writing session marked the end of the international Stop Torture campaign although we will continue to work on behalf of individuals who have been tortured or who may be at risk, as we always do.

Thank you very much to everyone who took part in the letter-writing and in the Stop Torture campaign.

**GOOD NEWS:** we were delighted to learn that Khadija Ismayilova was released on bail by Azerbaijan's Supreme Court on 25th May. This comes within weeks of Amnesty UK groups (including us!) sending letters and emails on her behalf as part of the May Monthly Action. Although we will never know for sure the reason for her release, it would seem that the increased pressure from Khadija's supporters may have contributed to the decision.
