Campaigning

General Election

At our February meeting Anne led a workshop looking at how we can get involved in lobbying prospective parliamentary candidates (PPCs) to make sure that human rights are on their agenda should they get elected. This led to the formation of a subgroup which has already met and started to plan.

Once all the PPCs have been announced, we will be asking you to write/email your constituency PPCs to make them aware of your views and to ask theirs, especially about the UK Human Rights Act and the Stop Torture campaign. We also hope that group members will attend local hustings to ask human rights linked questions and we are inviting PPCs from each of the main parties to our April meetings so that we can ask their views on these issues.

Stop Torture One Step at a Time

This major international campaign was launched in May last year. To mark the one year anniversary, we plan to hold a walk around Manchester City centre following the Manchester Peace and Social Justice Trail (see <u>http://www.discoverpeace.eu</u>). This will be lead by Steve Roman who helped put the Trail together and will be in aid of Amnesty. It will take about 3 hours to complete and passes by many important landmarks in Manchester with human rights links.

The EU are currently reviewing the arms control legislation. South America

We have received an Urgent Action concerning the Cabula shooting, when 12 young black community members were killed by the Military Police in Brazil. According to residents, all adolescents were deliberately assassinated. Local government made a statement saying that there is no evidence this operation was outside the law.

Please find the Urgent Action attached. Letters should be sent urging authorities to undertake a complete investigation and ensure resident's safety. Appeals must be sent before March 30th.
