Zimbabwe Actions

At the last Group meeting we marked the 10th anniversary of the formation of the Zimbabwean Human rights Organisation – Women and Men of Zimbabwe Arise. We signed a card which was sent along with some pictures to WOZA. A letter and a picture were also sent to the Embassy asking the Zimbabwean authorities to ensure human rights defenders are not subject to harassment during the run up to the elections in the summer.



Anne also represented Manchester at a demo outside the Zimbabwean embassy in London – we placed roses and our banner at the embassy entrance.

Last month we also sent letters to leaders of the Southern African Development Community and police chiefs in Zimbabwe. A further series of letter will be signed at the March meeting. If you want to take part in these actions, but won't make the meeting, contact [Anne](#)

Arms Trade Treaty

In July 2012 we came very close to securing a global Arms Trade Treaty (ATT). A draft treaty was drawn up, which could be effective, providing key loopholes are closed. This month, from 18 to 28 March the final UN conference will be held in New York. Amnesty believes that the ATT must have human rights at its core with a categorical rule that arms will not be supplied if they are likely to commit or facilitate a serious violation of international human rights law or international humanitarian law.

The UK Government has a crucial role to play in these negotiations. As a key global player it must continue to fight hard to strengthen the treaty, close the loopholes and make sure the treaty is not watered down by other governments. From now until the end of March we need to send a powerful message to MPs to ensure we get a treaty that will uphold human rights.

Burma – Dr Tun Aung

As outlined in the February Newsletter, our current case for Myanmar is that of Dr Tun Aung who has been held largely incommunicado in Sittwe Prison since his arrest on 11 June 2012 following increasing unrest in Rakhine State.



Unfortunately, the latest reports from AI UK are that there is no further news about Dr Tun Aung's case. However, in the 3rd phase of this campaign (7 February 2013 to 7 April 2013) we are now being encouraged to write to U

Aung Min of the Ministry of President Office, with copies to the Burma Human Rights Commission, as before.

Please ensure all letters are signed, as there have been reports of unsigned letters being sent to the authorities in Burma, which creates a poor impression and raises suspicions that a number of individuals are sending multiple letters.
