Campaigns

General Election

The aim of this campaign is to ensure that all newly elected MPs in parliament after the General Election are aware that human rights issues matter to their constituents.

Take the Pledge

Hustings

The group held our own mini hustings last month, having invited each of the major parties to send a representative from their PPCs within Greater Manchester. The panel consisted of the following candidates:

Kieran Turner-Dave (Green – Manchester Central)

Fiona Green (Conservative – Wythenshawe & Sale East)
Rebecca Long-Bailey (Labour, Salford & Eccles).

They were asked questions based around a human rights theme, covering issues including the HRA/ECHR, the anniversary of Magna Carta, Immigration & asylum (particularly with regards to conditions in detention), the arms trade, FGM/forced marriage, Stop Torture and the TTIP.

Most interesting and I hope that they went away aware of our strength of feeling on these issues.

To mark the one year anniversary of the launch of the Stop Torture campaign and in advance of the Global Day of Action to mark the UN International Day in Support of Victims of Torture, we will be hosting a walk around Manchester City Centre on **Sunday 7th June at 1pm.**

Starting at Victoria station, Steve Roman - who helped found the Manchester Peace and Social Justice Trail - will be leading people on a fascinating walk around the Trail (see <http://www.discoverpeace.eu>), discussing the importance of sites connected with the growth of Manchester as a centre for radical political activity and human rights.

The walk will take approximately 3 hours and will end at Gullivers in the Northern Quarter, where people can enjoy a cup of tea, sign some appeal cards, and find out more about the Stop Torture campaign.

Women's Rights

Acoustic Amnesty for Women's Rights - 16th July

The next Acoustic Amnesty fundraiser will again be at the beautiful Sacred Trinity church on Thursday July 16 2015. This time the acts are all female and we are fundraising for the excellent Manchester Women's Aid as well as Manchester Amnesty.

The gig will be seated and totally silent for performances with the (well stocked!) bar in a separate room. We are returning to our roots and there will be no sound system whatsoever - totally acoustic using the natural acoustics of the venue.

The acts are:

South America

Members of the Indigenous community of Cerro Tijeras in northern Cauca Department have been killed and others possibly forcibly disappeared. Further death threats against Indigenous Peoples in the area have also been reported. Amnesty has issued an Urgent Action calling for a full investigation of the deaths, to bring those responsible to justice – case sheet attached with the newsletter. Rodolpho will be bringing this to the group meeting for us all to sign however, if you have time please send your own appeal. Appeals must be sent before June 3rd.

Asylum Justice Project Launch.

We believe asylum seekers are not treated with the dignity, respect and care that they deserve.

AIUK have a new campaign on asylum to be launched at a meeting on **Saturday 16th May in York**. The focus of this meeting will be to further define the campaign areas, and to develop concrete actions in two of these areas: challenging indefinite detention of asylum seekers, and changing public perceptions of asylum seekers. The programme will include a panel discussion with Steve Symonds and Allan Hogarth from AIUK, in order to help focus the campaign in ways that fit with the work already being done by Amnesty. They are also planning several film showings, including 'Fit to fly' by Medical Justice.

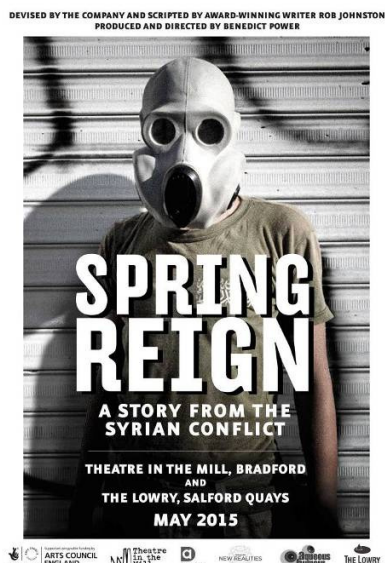

Spring Reign – A story from the Syrian Conflict



Syria has descended into civil war and Aleppo is besieged. Salah and Aisha have lost control of their lives and are plunging headlong into an uncertain future. The Syria they hoped to change is gone, in its place, violence and destruction - the arbitrary brutality of war. With the unexpected arrival of two Westerners, who have stayed too long in Syria and must now be given refuge, the fragile existence of the Syrian couple comes under even greater threat. How will they survive as they fall further away from hope, from what they know and from what they used to be?

Based on real-life accounts collected from Syrian refugees, aid workers, activists, journalists and photographers, Spring Reign features live performance, video, original music performed by Chris Davies, and frontline photography by Musa Chowdhury.

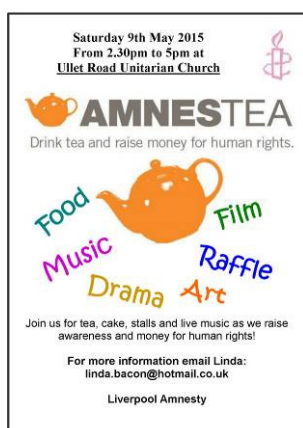
