Campaigns

Women's rights

We have just received a Campaign Update on Women's Rights in Afghanistan. As the introduction to the briefing points out, 2014 is likely to be a critical year for Afghanistan as international troops withdraw from the country and Presidential elections are held. There are very real concerns regarding the progress made on women's rights as things now seem to be going backwards again.

A range of actions are suggested in the new update for us to take -holding a reading event, a photo-action and further work with MPs. Our Women's Rights subgroup, lead by Mary and Marie-Louise, will be looking at how we can participate in this campaign. In the meantime, they will be leading a Twitter action to mark International Women's Day 2014.

Saturday March 8th is International Women's Day. This year we will mark this day with a stream of Twitter feeds featuring quotes and images on women's rights with an especial emphasis on women's rights in Afghanistan.

Syria

Our monthly action at the March Group Meeting will be to mark the 3rd anniversary of the Syrian Uprising – a grim reminder to the world of its failure to stop the suffering of the ordinary men, women and children caught up in the conflict.

Amnesty is part of a global coalition of NGOs and civil society who have created a joint campaign to mark the anniversary with a demonstration of solidarity with ordinary Syrian people. These actions will culminate in candle-lit / light based vigils attended by thousands of people across the world around major global landmarks on 13th March 2014. The aim is to demonstrate global solidarity with children, men and women struggling each day to survive the Syria conflict and improved access for the civilian population of Syria to basic necessities, including food, medical aid and fuel.

As well as signing some letters, we plan to hold our own little photo shoot in either St Ann's Square or Albert Square immediately after the group meeting. **We hope that you will be able to stay and take part!**



Zimbabwe

Anne has just received an update from the Zimbabwe coordinator. Once again WOZA members marched through the streets of Harare and Bulawayo on their traditional Valentines' Day demonstrations and were once again met with police brutality. On each occasion WOZA handed out roses and copies of a handbook on the new constitution. This was in great demand and WOZA quickly ran out of copies. Their demands were for implementation of the Constitution and for universal free primary school education by December 2014. The new constitution in several important aspects requires an improvement in basic rights for Zimbabweans.

We are asked to again write to the Police Commissioner about the police reaction to these peaceful demonstrations. Anne will be bringing letter for us to sign along to the group meeting.

Stop Torture

This major international campaign isn't due to start until the summer. However, we have had our first subgroup meeting as we hope to feature this campaign at an event during the Manchester Literature Festival in October. AIUK AGM 2014

Sex Worker Policy Consultation

We have now received a consultation pack on the issue of the policy that Amnesty should take regarding how best to protect the human rights of sex workers. This is a difficult area with strongly held opposing views but please note that the consultation will not change Amnesty International's longstanding position that trafficking into any form of forced labour, including forced sex work or any other aspect of non-consensual sex, should be criminalised as a matter of international law. This view is firmly expressed throughout the draft policy proposal.

Please find attached with this newsletter a short 2 page summary of the document (the full pack runs to 13 pages) which was put together by Eilidh Douglas for the Edinburgh University Group. If you want a copy of the full consultation papers, please email me <u>anne.walker9@ntlworld.com</u>.

If time permits, we will have a short discussion at the March group meeting but may well then decide to have a further separate meeting to thrash out our response to the consultation, which has to be in by 21st March. There will be further discussion and voting on the AIUK position at the AGM.
