## 3.0 Human Rights in South America:

- 3.1 Graham Minter gave a very interesting presentation surrounding Human Rights in South America his having been a diplomat in the region for several years allowing a deeper insight than perhaps otherwise would have been possible. He was able to highlight matters in Brazil and Chile, and a lively discussion developed surrounding various members' activism in the region over the years. Graham suggested that we join the specialist Facebook Page, also he would include our Group in the Regional Newsletter which is distributed quarterly.
- 3.2 A discussion developed surrounding the Paraguay Human Rights Organisation 'CLADEM' who had been supporting the family of a 10 year-old rape survivor, who in requesting an abortion, had been subject to malicious intimidation, harassment and surveillance. This of course has relevance to the 'My Body My Rights' Campaign, and to the safety surrounding Human Rights Defenders.

# ANNIVERSARY OF A FLOGGING

Amnesty activists outside the Saudi Arabian embassy in London on 9 January marked one year since jailed blogger Raif Badawi endured 50 lashes in a public flogging. We delivered a 250,000-strong petition urging the Saudi authorities to free Raif, who is sentenced to 10 years' imprisonment and 1,000 lashes. Our representatives made it only as far as the porch, but it was the first time that the embassy opened the door to us and accepted a petition.






# NI ABORTION LAW 'BREACHES HUMAN RIGHTS'

Belfast's High Court has ruled that Northern Ireland's abortion law breaches the human rights of women and girls. The historic ruling could end the ban on abortion in cases of sexual crime and serious malformation of the foctus.

Amnesty and local woman Sarah Ewart joined the Judicial Review, taken by the Northern Ireland Human Rights Commission, Sarah, whose first pregnancy was given a fatal foetal diagnosis, was forced to travel to England for a termination in 2013 as legally no one could treat her in Northern Ireland. She said: 'I, and many women like me, have been failed by our politicians. First they left me with no option but to go to England for medical care. Then, by their refusal to change the law, they left me with no option but to go to the courts on my and other women's behalf. I am an ordinary woman who suffered a very personal family tragedy, which the law in Northern Ireland turned into a living nightmare.'

Northern Ireland's Justice Minister and Attorney General are appealing the ruling, but we will resist all attempts to overturn it.
