<u>Saudi Arabia</u> — Saudi Arabia has one of the worst human rights records in the world - torture, public execution, discrimination, intolerance for free speech, possible war crimes in Yemen. Dozens of activists remain behind bars in the Gulf Kingdom, simply for exercising their right to freedom of expression and assembly. Please:

- write to the Prime Minister and Foreign Secretary about arms sales (we're supplying the Saudis)
- write to the Saudi Ambassador about Raif Badawi, who is still at risk of flogging,
- sign the on-line petition and write to King Abdullah on behalf of Ashraf, a 35-year-old poet and artist, who is sentenced to be executed by Saudi Arabian authorities for his art.

They are prisoners of conscience, held for their legitimate work as journalists. Please call for their immediate and unconditional release and urge the authorities to ensure that they are not tortured or otherwise ill-treated and that prison conditions and their treatment meet international standards. Stop Torture Campaign -

Andrew reported on the latest position on this campaign – as a Group we've had about 400 postcards signed and arranged exhibitions at both Southend High School for Boys, and Deanes School (99 cards in total from the latter two events). Andrew's current report on the Campaign, national and International, is on the Group website and attached to this Newsletter. Thanks to Andrew for all his work on this Campaign.

Burma - Nothing to report.

Sri- Lanka - Nothing to report.

Al UK Monthly Action – the principal action was a letter to the press about the sale of arms to Saudi Arabia and particularly the impact those sales were having in the Yemen. Tricia has already written to The Echo; Mike will ask her to also write to The Leigh Times and the Yellow Advertiser. We also wrote to David Cameron and Philip Hammond on this issue.

Saudi Arabia – we wrote to the Saudi Ambassador on behalf of Raif Badawi and to King Abdullah on behalf of Ashraf, a poet under sentence of death – details of these actions are on the front page of the Newsletter and on the website, along with a link to an on-line petition on behalf of Ashfar.
