STOP TORTURE CAMPAIGN

Mahdi 'Issa Mahdi Abu Dheeb

Mahdi Abu Dheeb, former President of the Bahrain Teachers' Association (BTA), has been in prison since his arrest on 6 April 2011. His family did not know where he was for 24 days. He spent 64 days in solitary confinement during which he says he was tortured. His family and lawyer were only allowed to see him during the first session of his trial before a military court on 7 June 2011where he was sentenced to 10 years in prison for a variety of "crimes" including inciting hatred of the regime. Amnesty International considers Mahdi Abu Dheeb to be a Prisoner of Conscience. Mahmoud Abu Zeid, popularly known as Shawkan

The Egyptian authorities have postponed until 23 April the trial of photojournalist Shawkan. He is facing trumped-up charges as a result of his journalistic work. Amnesty International considers him to be a Prisoner of Conscience and at risk of the death penalty if convicted. Please write to the Egyptian authorities on his behalf – there are more details and addresses on <u>the Group website</u>. **You should not write after 19th May 2016**.

Stop Torture Campaign – Nothing new. Andrew had found out a bit more about one of the cases that is still current – **Alfreda Disbarro** was apparently a police informer (!?) and the request for an investigation into the police referred to on her case sheet was completed a year ago – 2 members of the police were found guilty of "irregularities" and demoted one rank. Burma - Nothing to report.

Prageeth Eknaligoda, Sri- Lanka - Nothing to report despite the indication that April might contain a "significant anniversary" when we would actually take some action. As we have had this case around a year now with no sign of any activity and nothing from AI UK it does not seem to be active; **Doug** will write to the Derby Group, which has also adopted Prageeth to see what their experience is, and **Mike** will write to AI UK querying the lack of activity and also the lack of response to the 2016 Option Form.

AI UK Monthly Action – AI UK wanted us to write to the Burmese authorities on behalf of Phyoe Phyoe Aung but she was released before we met. A successful campaign!
