# PRIDE 2012



Brighton Pride was on Saturday 1st September this year, one month later than usual so as not to rival the Olympic Games! Celia prepared rainbow coloured ribbons on which to write messages of solidarity for Gay Pride marches in South Africa.

In addition to this we were asking people to sign postcards to Colonel Petras Shilane at Tsakane Police Sta-

tion in South Africa. This was to urge him to investigate the death of Noxalo Nogwaza, a human rights defender campaigning for the right to equality for lesbian, gay, bisexual, transgender and intersex people. Noxalo was murdered on her way home from a night out with her friends. She was raped, beaten and stabbed before her body was dumped in a ditch. No progress has been

made in the investigation.

We had 7 people helping on the stall including Martin, a volunteer from London, and Celia's granddaughter. All 300 ribbons had messages written on them, like 'Fight Homophobia' and 'In Solidarity with LGBT activists'. These will be parcelled up and sent to South Africa, to be given out by supporters at Gay Pride marches. We had 100 people sign the postcards on the day.



Mostly people were happy to participate in this campaign as they made their way in good humour along the route of the parade to Preston Park. I asked one person to sign in solidarity with South Africans. He replied that he was from South Africa and that it was all 'nonsense'. Unfortunately he didn't stop to explain. I would have been interested to hear what he had to say on the matter!

## **Vedanta's human rights promises are 'meaningless and hollow'**

Amnesty International has accused the UK-registered, FTSE 100-listed mining company, Vedanta, of attempting to 'gloss over' criticisms of its poor human rights record in the East Indian state of Orissa.

In the last few years Vedanta's operations have been under increased scrutiny. In response to the resulting pressure from bank lenders and investors, the company has recently developed a human rights and sustainability policy and published a report entitled 'The Lanjigarh Development Story: Vedanta's Perspective'. Although these recent developments demonstrate the strength of Amnesty's influence (Vedanta directly refers to Amnesty in its report), Amnesty believes that these policies fail to address the persistent human rights concerns associated with the company's operations in Orissa.

Amnesty's new briefing, 'Vedanta's Perspective Uncovered: Policies cannot mask practices in Orissa', draws upon evidence received from communities affected by those operations and on the findings of non-compliance by India's regulatory authorities and other official bodies from 2010 - 2012.

It particularly focuses on Vedanta's:

- non-recognition of the rights of indigenous peoples,
- inadequate consultation with local communities,
- non-compliance with India's national law,
- failure to address health and pollution concerns,
- involvement in attempts by the police to silence its critics on the ground, and to deter some journalists and researchers from investigating operations and
- general lack of disclosure of information.

Polly Truscott, Deputy Director of Amnesty International's Asia-Pacific Programme, said

'New evidence from the communities in Orissa shows that changes announced by Vedanta have had little positive impact on the livelihoods, rights, and other concerns of the communities on the ground.'

## ARMS TREATY NEWS UPDATE



In July UN member states met to try and secure the world's first Arms Trade Treaty. Unfortunately due to delaying tactics by some states, notably the United States and Russia, a draft treaty was not agreed upon. Great progress had been made and a strong draft treaty had been presented, although from Amnesty's point of view several loopholes still remained. Afterwards there were encouraging statements from Jo Adamson, the UK's representative at the UN, and William Hague, who expressed disappointment at the failure to agree a treaty.

All is not lost however. UN states meet again in October where it is likely a majority agreement will secure a treaty (rather than having to use consensus, as was the case in July). In preparation Caroline Lucas, MP for Brighton Pavilion, has been keeping up the pressure on the government to deliver a bullet-proof Arms Trade Treaty. In parliament on 4th September she raised the Arms Treaty negotiations with Alastair Burt, an MP at the Foreign Office. He said that good progress had been made and that the government are "... *recommitted to doing everything we can to see that base built upon, and we hope to make progress as soon as possible towards the treaty, which we hope will be in the next UN session beginning this month.*" Caroline Lucas asked whether he was concerned that ammunition may be subject to fewer restrictions than conventional arms, to which he gave a general answer, ending by saying "...*In company with civil society, non-governmental organisations and other partners, we will look for the process that is most likely to improve it (the draft treaty) and we will work with partners on the best way of taking steps forward.*"

On 17th September two Labour MPs, Douglas Alexander and Jim Murphy, wrote a letter in the Guardian newspaper arguing for more scrutiny by the government prior to agreeing arms exports. This comes in the wake of revelations that Britain approved arms exports to Libya under Gaddafi, Egypt under Mubarak, Bahrain and Saudi Arabia (amongst others). Despite revoking several arms licences after popular revolutions in the middle-east, the UK government has resumed arms sales to Bahrain amid a violent crack-down by the Bahraini government. The two Labour MPs argued that failure to agree on a legally binding Arms Treaty was a "stain on the international community" and echoed calls by Amnesty and other NGOs to do all we can to secure an Arms Treaty when UN states meet again in October.

Seven films. Five workshops. Four performances. Three live acts. Two art installations. One marquee. One theme: the Arab Spring.

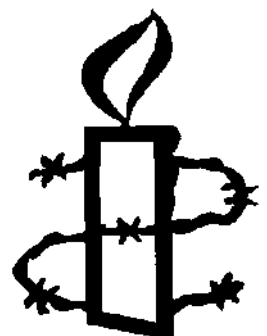
Join us for Brighton's first ever festival of Arabic arts and culture in the Royal Pavilion Gardens, from 5 to 7 October 2012.

**CUBA****Members of The Ladies in White (Damas de Blanco) and other opposition activists in Cuba**

The Ladies in White was formed by a group of female relatives of the 75 prisoners of conscience who were imprisoned in March 2003 for their peaceful expression of critical opinions of the government. The group would attend mass every Sunday in the capital, Havana, dressed in white, to pray for the release of their relatives. Afterwards they would take part in a procession from the church to a nearby park, carrying white flowers.

Members of the Ladies in White have been detained in Havana and several other places in Cuba. Some remain in detention and the authorities have failed to provide reasons for their detention or information on their whereabouts.

From 21 to 24 September the Ladies in White (Damas de Blanco) held several activities, including masses and marches in Havana, to celebrate the feast day of Our Lady of Mercy (Virgin de la Merced) and in memory of former political activists. Since 20 September, various members of the Ladies in White have received intimidating notes aimed at preventing them from taking part in activities. Reports from the group state that the headquarters in Neptune Street, Havana have been surrounded by police officers.

Around 50 members of the group, who travelled from different provinces of Cuba to attend the activities, were arrested on their way to Havana. The majority of them were released and deported back to their provinces, however 19 remain detained and their whereabouts are unknown. On 24 September as the Ladies in White planned to attend mass, an act of repudiation (acto de repudio - see background information) took place at their headquarters. Government supporters and state agents gathered in the street chanting pro-government slogans and intimidating the women. In the early morning of 25 September 18 members of the Ladies in White were arrested at the headquarters.

Amnesty International believes that the repeated use of short term detentions of members of the Ladies in White and other activists in Cuba is a tactic used to silence dissident voices in the country and prevent peaceful activities. Furthermore the systematic arrest of activists travelling from the provinces to Havana represents an excessive limitation to freedom of movement and represents excessive control and harassments of dissidents.
