- A great annual event for our group, Reading's Pride saw over many actions taken for LGBT rights. Over 130 action postcards were signed for Noxolo, a South African activist who was brutally murdered, with no investigation into her murder. Streamers were signed to send support messages to the South African Pride later this year. Cards of support were signed and sent to a Turkish man who's partner was killed in an "honour" killing, many suspect by his father.
- In our September group meetings, we had a fascinating talk from **Ferran Nogueroles, Amnesty activist from the LGBT network**. He talked passionately about the challenges facing the Baltic Prides, where he has been a participant and an observer for many years.

**Thongpaseuth Keuakoun and Seng-Aloun Phengphanh**

Thongpaseuth Keuakoun and Seng-Aloun Phengphanh are two former student activists who have spent 14 years in prison after organising a peaceful demonstration in Vientiane calling for political, social and economic change in Laos. The demonstration, in which students attempted to put up banners, occurred in October 1999.

They remain in Samkhe prison.

According to Lao official media, the National Steering Committee on Human Rights has been set up to 'stimulate the Lao government's efforts to promote and protect human rights'. Can I urge you then, as the Chair of the Steering Committee and also Head of the President's Office, to arrange for the unconditional release of Thongpaseuth Keuakoun and Seng-Aloun Phengphanh who I believe are prisoners of conscience. Pending their release, please ensure they are allowed visits from their families and have access to medical treatment.

**Re: Pro-Democracy Activists face 12 years' imprisonment**

We are concerned that additional charges of planning acts of 'public disorder' which carry terms of up to 12 years in jail have been brought against eight youth activists.

Pro-democracy youth activists **Bakhtiyar Guliyev, Mahammad Azizov, Shahin Novruzlu, Rashad Hasanov, Rashadat Akhundov, Zaur Gurbanli, Uzeyir Mammadli** and **Ilkin Rustamzade** were arrested between March and May 2013 and charged with possession of drugs and explosives, and hooliganism. Amnesty International declared them prisoners of conscience. On 12 September, they were additionally charged with planning to organize acts of public disorder and using Molotov cocktails on 10 March protest against deaths in the army.

Police claim to have found Molotov cocktails in **Bakhtiyar Guliyev** and **Shahin Novruzlu's** homes on 8 March, but their parents insist these were planted when plainclothes officers searched their houses. **Bakhtiyar Guliyev** and **Mahammad Azizov** attempted to withdraw "confessions" they had given without lawyers of their choice being present. **Mahammad Azizov** told his lawyer he had been beaten after refusing to testify against **Rashad Hasanov**. Their "confessions" were later shown on state television. Instead of investigating allegations of torture and ill-treatment by the state, the authorities continue to rely on their "confessions".

According to defence lawyers, there is no link between the three activists accused of preparing Molotov cocktails and the others, apart from organizing a peaceful protest. All eight deny the charges against them.

As the eight youth activists: **Bakhtiyar Guliyev, Mahammad Azizov, Shahin Novruzlu, Rashad Hasanov, Rashadat Akhundov, Zaur Gurbanli, Uzeyir Mammadli** and **Ilkin Rustamzade**, are prisoners of conscience, detained solely for the peaceful exercise of their rights to freedom of expression, assembly and association, we therefore call on the Azerbaijani authorities to release them immediately and unconditionally.

We further urge you to launch an urgent, objective and effective investigation into allegations of torture and ill-treatment, especially concerning **Bakhtiyar Guliyev, Mahammad Azizov** and **Shahin Novruzlu**.

Finally, we call on the authorities to ensure that the rights to freedom of association, assembly and expression are respected and no-one is persecuted for the peaceful exercise of their rights.

We look forward to your immediate response to these serious matters.
