## Myanmar

### Conference to define

#### “What constitutes a Political Prisoner?”

“The definition states that anyone arrested, charged or sentenced for directly or indirectly supporting movements for freedom, justice, equality, or human rights, or for participating in demonstrations or other forms of dissent against the government, would be considered a political prisoner.

“According to the definition that came from the workshop, a political prisoner is anyone who is arrested on political charges or other penal code-based violations, if they were protesting against the Constitution or the government's conduct, including the president and all government officials.”

This definition of a Political Prisoner is the result of a workshop convened in Rangoon by the Former Political Prisoners Society and the Thailand –based Assistance Association for Political Prisoners, and held in Dhamma Peya monastery August 17th – 18th this year.

Tun Kyi, one of the organizers said “ It is necessary to articulate a definition of Political Prisoners as the government of Myanmar is denying that any political prisoners remain behind bars. Aug

Thein the Presidents Office deputy minister maintains that all political prisoners were released by the end of 2013, to fulfil the promise President Thein Sein made in July that year.

But as Amnesty International knows, political motivated arrests are still being made, and prisoners are tried and convicted on alleged criminal charges. This allows the authorities to stifle dissent and to limit freedom. Activists have decried the intimidation, arrest and prosecution of dozens of people this year, ranging from activists and farmers to journalists and politicians. Often they are charged under laws still on the books but considered undemocratic, such as the Peaceful Assembly Law, which until recently required pre-approval from local authorities to stage a protest.

Aung Myo Kyaw, a spokesman for the AAPP, said workshop participants would submit the finalized definition of political prisoners to Parliament.

*“The government no longer recognizes political prisoners [as still existing]. So now we have a definition, which was agreed upon by the various organizations and will be sent to Parliament to get recognition from the government,”* he said.

We have just received an Urgent Action which clearly shows that people are still being arrested for political reasons. This concerns five media workers in Myanmar who are facing imprisonment over the publication of a news story. AI considers them prisoners of conscience, detained solely for peacefully exercising their right to freedom of expression. Our campaign lead, Jean, will bring along details to the group meeting and a letter for us all to sign.

## Southern Africa

A new action on South Africa has been sent to us by the new South Africa country coordinator. It concerns the Treatment Action Campaign (TAC) which is a leading civil society organisation advocating comprehensive health care services for people living with HIV in South Africa. TAC members are often subjected to intimidation and threats. They try to advocate access to treatment, care and support for people living with HIV. Since 1998, TAC has demanded accountability from the South African government for health care delivery, campaigned against “AIDS denialism” during the presidency of Thabo Mbeki, challenged the world's leading pharmaceutical companies to make treatment involving life-saving medicines more affordable and cultivated community leadership on HIV/AIDS.

Various members of TAC have been subject to harassment on an ongoing basis and we are asked to send messages of support and to write to the Premier of Free State Province. Anne will bring along a messages for us to sign at the group meeting, however if you aren't able to attend, details of the action are attached with this newsletter.

### Manchester Literature Festival



We are proud to present an afternoon with Sri-Lankan born artist, writer and film-maker, Roma Tearne. Roma was a Fellow at Oxford Brookes University and has had many national and international exhibitions. It was while working as Leverhulme Artist in Residence at the Ashmolean Museum, Oxford, that she began to write.

Roma's writing is both informed and inspired by her, and her family's experience of fleeing Sri-Lanka. She has written five novels and will be reading from her book *Brixton Beach*, a TV Bookclub pick and winner of a French Reader's prize, and *The Swimmer*, which was longlisted for the Orange Fiction Prize. Both novels offer the reader 'a rare insight into the subtle and dramatic ways we are shaped by conflict' and draw on issues of civil war, persecution and torture, migration, self-identity and loss. Roma's talk will be followed by a Q&A and book signing and all proceeds will go to Amnesty International.


