## Stall at Brighton Pride 2013

This year we had our stall outside the Amnesty Bookshop in Sydney Street instead of at the Pride event in Preston Park. The flamboyant parade with outrageous costumes and extrovert behaviour went down London Road which is parallel to Sydney Street. Many people made their way to the event passing our stall so it was a good position to be in.

We had three actions on the stall:-

There were letters to sign about Ahmet Yildiz, a Turkish gay man

who was killed by his father in an 'honour' killing in 2008. We are asking the Minister of Justice to investigate the murder as no action has been taken so far.

We signed a letter to send to Ahmet's partner in sympathy and solidarity with him.

We had a large rainbow flag which we signed and will send to LAMDA (Turkish gay organisation) in Istanbul to encourage them in their work for equality for gay people.



There was a joyful atmosphere and most people that were asked were pleased to join in the actions. A hundred letters were sent to the Ministry of Justice in Turkey.

### ARMS TRADE TREATY UPDATE

On 2<sup>nd</sup> April 2013 the UN voted to adopt the Arms Trade Treaty that Amnesty and so many others have been fighting for for many years. 154 states voted to adopt the treaty, 3 voted against (North Korea, Iran and Syria), and 23 abstained from voting (including China, Russia, Saudi Arabia, Egypt and India).

In order for the treaty to enter into force, 50 states must sign and then ratify it. At the time of writing, 83 states have signed it, and 4 have ratified it. This process takes some time as ratification involves action by the state at a national level, after discussion by that states government / parliament.

The 4 countries to have ratified the treaty are Antigua & Barbuda, Guyana, Iceland, and Nigeria. Of the 83 countries to have signed the treaty, the US is not yet one of them, however Secretary of State John Kerry has publicly committed to signing it. The main issue will be getting the treaty ratified by the US Senate, which will require a 2/3 majority.

The UK has signed the treaty and is expected to ratify it.

Currently the UK has one of the strictest controls on arms exports in the world, but still approves arms exports to countries such as Saudi Arabia, Bahrain, and Egypt - all of whom have reportedly used such weapons against their own people.

*Ratify the Arms Trade Treaty as soon as possible.*

**Treasurers Report**

Amnesty International Brighton and Hove have received a generous donation of £401 from a Tea Party organised by a local resident.

**Monthly Action and mailing from head office – Liz**

- There has been no monthly mailing sent this month (possibly not arrived yet as it is 1<sup>st</sup> August). Group agreed to do 2 monthly actions next meeting.
- The group signed letters to Eduardo Montealegre in Colombia in support of Diego Martinez and Jelson Paba, human rights defenders who have been receiving death threats after participating in an International Youth for Peace event.

**Monthly stall – Jill and Celia**

- Last months stall was successful with over 100 postcards sent to the Guantanamo hunger strikers and many donations given.
- Next stall will be at Pride Saturday 3<sup>rd</sup> August from 1-3pm where people will be asked to sign a flag/banner to support LGBT rights.

**Monthly letter writing evenings – Jill’s House 17th September 37 Richmond Road.**

**Prisoners of Conscience – Displaced people of Tawargha – Jill**

Jill has written to the Mayor to ask him to write to the Misrata council. It is hoped this will put higher pressure on Libya with the Mayor having more authority and influence.

**Afghan Women’s Rights –Stall at Brunswick Festival 17th August**

- There will be a stall on 17<sup>th</sup> August from 12-5 at the Brunswick festival with a head scarf for supporters of Afghan women’s rights to add purple fingerprints to. Emma has also got some blown up photographs of Caroline Lucas signing the pledge to display. The group suggested dressing up in traditional Afghani dress.

**Security and Human Rights – Michael**

- Bradley Manning - maximum penalty would be 136 years.
- Edward Snowden has received 1 year asylum in Russia.
- There has been a good public response and solidarity to the Close Guantanamo campaign.
- There are possible moves afoot to move Shaker Aamer to Saudi Arabia on his release.
- There has been a new appointment in America of Clifford Sloan whose mission it is to implement the closure of Guantanamo. Amnesty supporters can write to him at:

## **URGENT ACTION – EGYPT MEANS TO DEPORT REFUGEES INCLUDING CHILDREN**



The Egyptian authorities are preparing to deport 13 Syrians to Turkey and 28 Palestinians from Syria to the Gaza Strip. The group which includes at least 13 children and 10 women, had sought refuge in Egypt after fleeing conflict in Syria. Under international law, Egypt has a responsibility to protect people fleeing the conflict.

They were arrested on 9<sup>th</sup> August near the port of El-Dekhela in Alexandria. A prosecutor ordered their release but the security forces

have continued to hold the group in El-Dekhela police station for “national security” reasons. After the immigration office classified the group, the government ordered that the 13 Syrians be deported to Turkey and that the 28 Palestinians who have been living as refugees in Syria, be deported to the Gaza Strip. The office of the UN High Commissioner for Refugees in Cairo has confirmed that at least 8 of the Syrians are registered as refugees. All the Palestinians hold documents or file numbers showing that they are registered with the Syrian office of the UN Relief and Works Agency for Palestinian Refugees in the Near East.

Anyone fleeing the conflict in Syria should be considered to be in need of international protection, including Syrian nationals and Palestinian refugees who live in Syria. The responsibility for providing this protection falls on the country where these individuals are, in this case Egypt. In particular, Egypt is a signatory to the Organisation of African Unity Refugee Convention, which regards people fleeing internal armed conflicts as refugees.
