Jailed activist at risk of going blind



Jailed Iranian-Kurdish activist Zeynab Jalalian could go blind because she is being denied urgent medical treatment. Her severe eye problems may result from the beatings she received during interrogations.

Zeynab was jailed in March 2008 for supposed links to the military wing of a Kurdish opposition group. Her grossly unfair trial only lasted a few minutes. No evidence linked her to armed activities, and she says her conviction was based on 'confessions' extracted through torture.

Before her trial, Zeynab was detained for eight months. She says her head was repeatedly rammed against a wall. Her skull was fractured, causing bleeding in the brain.
