### ZIMBABWE ELECTIONS 31 JULY 2013: VOTE FOR HUMAN RIGHTS – order your campaign pack now!

Dear Activist,

I'm emailing with an important update relating to the **Zimbabwe Elections: Protecting Human Rights Defenders** campaign. This is further to the briefing you should have received in last month's mailing.

You may have seen in the media that President Mugabe has just announced the date for the Zimbabwe elections: they are due to take place on  $31^{st}$  July – though it is worth noting that Prime Minister Morgan Tsvangirai is disputing this date.

When Zimbabwe last held elections in 2008, unprecedented levels of politically-motivated human rights violations took place. More than 200 people were killed, 10,000 injured and 28,000 forced to flee their homes. With less than 7 weeks to go until the polls are due to open, it is so important that we take action now to avoid a repeat of the violence and fear seen five years ago.

In 2008 it was Zimbabwe's neighbours in the Southern African Development Community (SADC) who helped to reduce the violence. Now it is crucial that they act to prevent such bloodshed from happening again.

# What you can do:

Please help us to collect as many signatures as possible on **new action cards** addressed to the President of Tanzania, the Chair of the SADC group responsible for peace and security in the region.

To help you do this, we have produced an **activist pack** to support you in organising a stall with the look of a polling station, to help attract interest and engage people beyond your group with the campaign and get them taking action.
